I. WELCOME

At 3:32 Co-Chair Leonard Schleifer called meeting to order, and reported that this was going to be a busy meeting, as the Council had a lot of business to accomplish: voting on the Priority Projects, and approving the Progress Report to send to the state.

Leonard turned the meeting over to Co-Chair Dennis Murray, who thanked the Council members, Executive Director Meghan Taylor and the regional office staff for the great work done on the Progress Report, and Pattern for Progress for the work and outreach done for the URI. Dennis turned the meeting over to MHREDC Executive Director Meghan Taylor, who went over the agenda:

Upstate Revitalization Initiative Update

II. PRIORITY PROJECT UPDATE

The CFA opened on May 1, 2015. It closed on July 31st at 4 PM. The Regional Councils were tasked with submitting the Progress Report on September 21st, and the URI Plan is due on October 5th. Sometime in the late fall the Awards Ceremony for Round 5 of the CFA will be held.

Meghan briefly went over the 2015 Competition Criteria. Each of the REDC's were asked to do the following:

- Develop a Regional Industry Cluster Plan
- Update the Global NY Plan and identify projects
- Update ongoing regional initiatives in the Progress Report
- Build on and expand the Regional Project Pipeline
- Continue the Strategic Plan Implementation
- Refine Workforce Develop Strategies
- Update Performance Measures

Meghan briefly described the Ongoing Core Strategies for the Mid-Hudson:

- Red Circle: Investing in Technology (Biotech, Biomedical & Healthcare, IT and Advanced Manufacturing)
- Purple Circle: Attracting & Retaining Mature Industries (Financial & Professional Services, Food and Beverage and Distribution)
- Green Circle: Grow Natural Resources (Agriculture, Waterfront Development, Tourism and Arts & Culture)
- Blue Circle: Revitalize the Region's Infrastructure (Infrastructure, Housing and Urban Centers)

She then compared the Ongoing Core Strategies to the URI Strategies:

- Work Strategy This is a combination of the Red Circle and the Purple Circle, as the food and beverage manufacturing slides into this strategy.
- Play Strategy This is a continuation of the Green Circle.
- Live Strategy This is a combination of the Blue Circle and the Purple Circle, as the development strategies pursued by developers and industries cluster in the urban areas, so too, must the financial & professional services and distribution sectors.

III. UPSTATE REVITALIZATION INITIATIVE UPDATE

Co-chair Leonard Schleifer thanked Pattern for Progress for their hard work on the URI Plan, and turned it over to March Gallagher of Pattern to lay out the URI Plan for the Council and the public.

March commented that it was a tremendous honor to work on the URI for the Council.

March explained that the central premise of the plan is that the Mid-Hudson is the best region for the state to invest \$500M before explaining that the theme of Live, Work and Play was chosen as they all capture everything we have to offer the state.

LIVE

Encourages smart growth and transit oriented development, spurs downtown revitalization and infrastructure improvements to stimulate job creation. March stressed that urban centers are from Yonkers to Monticello; villages and hamlets are classified as urban centers in this plan. All of this includes waterfront development, renewable energy improvements, and urban farming.

WORK

Leverage our education systems to improve all levels of our workforce, fosters an innovative culture and increases private sector investment, and develop a paid internship program for underrepresented students for grantees. The Mid-Hudson has the most patents than any other

upstate region, so it makes sense to continue investing in our already existing bio-tech, advanced and high-tech manufacturing, IT and food and beverage manufacturing sectors.

PLAY

Seeks to position the region as a scenic tourist destination based on the region's scenic beauty, local agriculture, food and beverage industry, its arts, culture, history and recreational assets, as well our proximity to NYC, the world's biggest tourist destination. We plan to build the Hudson Valley as a brand of its own. March stated that even capturing 1% of the NYC market will create 6400 jobs and \$400+ M in revenue annually.

March tied it all together when she discussed the Projects & Partnerships that the URI envisions for each strategy:

LIVE

Enhance urban centers to reduce pressure on greenspace Replicate the Greyston Bakery Open Hiring Model Urban farming and renewable energy projects

WORK

Develop next generation cyber security expertise Regional biotech expansion Live-work innovation entrepreneurship spaces

PLAY

Several resort and tourism projects

Expand and cultivate food and beverage industry

Create and facilitate regional transportation planning

Co-Chair Leonard Schleifer thanked March and Pattern for their work on the URI, and congratulated March on her new job with the Community Foundations of the Hudson Valley.

Co-Chair Leonard Schleifer moved to approve the URI plan consistent with the presentation, subject to final approval. Council Members Ned Sullivan, Ken Kleinpeter, Carol Fitzgerald and Paul Ryan seconded the motion.

All voting members approved unanimously by voice vote.

MHREDC Executive Director Meghan Taylor commented that she wants to invite Ms. Madison to be part of the Food and Beverage workgroup.

Peter Feinman; writes about NY History; stated that he is very pleased to see Tourism is being bought back here to where it began. Co-Chair Dennis Murray stated that we should put you on a workgroup as well.

Council member Ken Kleinpeter quipped that putting folks on workgroups is a great way to discourage public comment!

MHREDC Executive Director Meghan Taylor informed the Council that the Regional Office will submit Progress Report on Sept 21; and that announcements from the state will occur sometime in late fall; historically it has been early December, but announcements will be forthcoming as soon as we have a date.

All progress reports will be available to the public once it has been submitted.

Co-Chair Dennis Murray made a motion to adjourn, Paul Ryan seconded at 4:02 PM.
