I. Executive Summary

Overview of Vision and Strategic Objective

Vision

Building on a strong foundation of existing businesses and higher education institutions, the Southern Tier region uses a collaborative approach to leverage its globally competitive advantages to attract talent and investment for the development of industry clusters. Our focus will be on increasing the size and prosperity of the region's workforce through new business creation based on high-technology discoveries and other entrepreneurial activities, while ensuring healthy communities and protecting the natural beauty and resources of the region.

Overview of Strategic Objectives

Strategy 1. Energy Efficiency & Renewable Energy Technology

Objective: Optimize use of the region's abundant natural resources, research and technology transfer, academic and business innovation and training programs to build a thriving energy sector for the benefit of residents, institutions, businesses and major industrial centers.

Strategy 2: Manufacturing and Transportation Industries ... Next Generation Technology and Advanced Manufacturing

Objective: Build the region's advanced manufacturing sector and transportation industries into a global leader and technological hub for next generation development.

Strategy 3. Health Care 2020

Objective: Develop cutting edge technology and expand the use of sophisticated diagnostic tools and care methods, together with training of health care providers and technical personnel, to strengthen the healthcare industry while creating a healthier population and workforce region-wide.

Objective: Expand and increase the sustainability of agricultural and forestry ventures through research and new product development, promotion, business infrastructure development, and utilization of new technology with a focus on the growth of value added product development such as cheese, yogurt, wine, beer and spirits.

Objectives:

- Community Revitalization: Revitalizing the region's downtowns, main streets and neighborhoods provides opportunities for smart and sustainable community development and growth, increased tax bases, retention of businesses and ancillary economic benefits, and attraction and retention of talent.
- Infrastructure for Shovel Ready Sites: Shovel ready sites enable the Southern Tier to be more competitive, expeditiously respond to opportunities, reduce costs for business development and more effectively leverage public and private investment.
- **Broadband Infrastructure**: State-of-the-art connectivity means uninterrupted broadband service that meets the demand of universities and major business users, fills a critical gap in business recruitment and retention efforts, promotes entrepreneurial activities and allows health care providers to expand services in the most rural areas of the region.
- Workforce Development: There is an immediate need to develop aggressive workforce training programs specific to the needs of emerging growth industries, and multi-sector innovation that will translate to competitive compensation for the region's workforce, attract talent and position the Southern Tier to be globally competitive.
- **Business and Technology Development:** The region currently includes the strongest manufacturing base in the state's ten regions and the associated cluster businesses, with the expertise and partnerships in place to expand businesses and also integrate these independent projects through the university-industry relations designed to catalyze and support collaborative growth in emerging economic sectors.
- **Tourism and Waterfront Development:** The region is known for its vast natural resources and its many tourism and cultural destinations, as well as its natural beauty. Growing the tourism industry and enhancing the waterfronts has been established as a priority by the Council.

Strategy #6. Technology Development and Transfer ... A Job Generator

Objective: Increase the amount of technology being commercialized by regional research sources, the number of companies being formed in the region, the success rate of companies being formed, and the number of students educated in the region who then remain in the region to start companies.

Strategy #7. Opportunity Agenda

Objective: Move the impoverished population into the workforce by pursuing projects and initiatives that:

- Involve joint efforts between educational institutions, employers and community organizations.
- Move impoverished people living in the targeted geographic areas into employment, preferably in job categories identified by the Regional Council.
- Build human capital through learning of new skill sets.
- Ensure residents of target areas have the tools to secure and retain jobs in targeted job categories while meeting employer hiring needs.
- Remove barriers to employment such as transportation, child care and lack of education and training.
- Revitalize distressed communities by revitalizing buildings and neighborhoods, and creating businesses and job opportunities.

Public Engagement



During 2015 the Council took several actions to engage the public and stakeholders in the implementation of its regional strategies and state-wide initiatives, identification of new strategies, and promoting awareness of the region's plan. A total of 17 work groups sessions were held, involving more than 330 participants. Four CFA workshops were held through the region with 152 people in attendance. In addition, an on-line opinion survey was conducted and received 509 individual responses. A detailed description of the work group activity is contained in Section IV of this report.

One-on-one meetings and technical assistance are considered to be among the most valuable tools in identifying projects to implement the Council's strategic economic development plan and achieve support for

the Governor's initiatives. Representatives of the regional ESD office and council members were actively engaged in one-on-one meetings with municipal leaders at the county, city, town and village levels to discuss the feasibility of projects, facilitated collaboration among government entities, brought together public and private sector partners, identified resources and linkages to SART, and provided guidance in selecting potential funding paths through the CFA Round 5.

Update on the Southern Tier's Economy

The Southern Tier economy is Upstate's fifth largest in terms of jobs, and accounts for 7% of total jobs and nearly 6% of all firms in the area. Since 2000, the Southern Tier has lost 6% of its labor force, compared to growth at the state and national level (5% and 9%, respectively). Simultaneously, the region's poverty rate continues to rise. The Southern Tier poverty rate was 16% in 2013, slightly above the state's 15%.

Despite these facts, the Southern Tier is making strides. In fact, overall wealth is increasing in the Southern Tier.

- ✓ Since 2009, the median household income of Southern Tier residents has increased by 8%, above the rate of inflation. In 2013, the median household income was just over \$48,000, compared to \$58,000 statewide. The state median income increased by just 5% over the same time period, indicating that growth is stronger in the Southern Tier than the state as a whole.
- ✓ The unemployment rate, at 6.1% in 2014, is slightly below state and national unemployment rates (6.3% and 6.2%, respectively).
- ✓ Since 2009, jobs have been added to food manufacturing, education, health, and professional, scientific and technical services.
- ✓ The Southern Tier is over achieving in terms of global exports and proportion of jobs in STEM-intensive industries.
- ✓ Gross regional production is on the rise, with an estimated increase in gross regional product of nearly 15% between 2011 and 2013. In 2013, the total gross regional product was \$28 billion, up from \$27.2 billion in 2012.
- ✓ In comparison to jobs and firms, the Southern Tier is performing on par with other Upstate regions in terms of total gross metropolitan output.
- ✓ Exports grew to \$37 billion in 2013, and represent nearly 11% of all upstate export activity.
- ✓ The region's STEM-intensive employment base remains relatively strong and the average annual wage of \$72,308 in these industries remains very high compared to the regional average wage of \$42,235.
- ✓ There are signs of movement into the region. Chenango, Delaware, Tioga, and Tompkins counties all experienced growth in the number of residents under the age of 20 moving into the region. In addition, there has been movement into some of the most distressed communities such as Norwich, Elmira and Corning where there is evidence of decreasing residential vacancy rates.
- Commercial and industrial vacancy rates are declining in the Greater Binghamton area. Both commercial and industrial vacancy rates are down to 10% from a high of 14% in 2012.

Manufacturing, which employs 34,000 workers, remains an area of strength for region in terms of institutional knowledge and employment. Annually, the industry contributes more than \$2 billion and generates \$11.6 billion in exports. It has a location quotient of 2.5, with 8.9 LQ in the Transportation Equipment cluster. It also dominates with an average annual wage of \$61,800, which is 41% above the average for all industries in the region (\$43,700), and the average annual wage in the Transportation Equipment Manufacturing cluster is \$73,800.

The Agriculture Industry has been growing at a steady pace, with an overall employment increase of 23% between 2010 and 2014. Employment in food manufacturing has grown 41% since 2009 with over 1,000 net new jobs, while the food processing cluster increased employment by 18% over the same time period. The location quotient for agriculture is 2.9, and combined with forestry it is 1.9, indicating a strong presence in the economy. Food manufacturing contributes nearly \$4 billion in exports to the regional economy, while crop and animal exports contribute over \$830 million (EMSI). The food and agriculture industry cluster also impacts the region's economy with a jobs multiplier of 2.33 and a sales multiplier of 1.70.

The tourism industry also is growing. Visitor spending reached \$.87 billion in 2011, representing an 18% rise from where it was two years earlier – notably more than the 12% increase reported across Upstate, and on par with New York State's 18% increase.

Tourism jobs increased by 8% between 2009 and 2013. The average annual wage for this sector increased by 15% during the same time period. Adjusted for inflation, the increase was 5%, notably higher than the 1.5% overall dip in the region's private sector wages.

New Regional Initiatives

As a result of the Upstate Revitalization Initiative planning process, the Southern Tier REDC adopted four new initiatives that will drive its next 5-year plan to build an advanced economy. The plan includes the following four initiatives.



Build the Greater Binghamton Innovation Ecosystem

Greater Binghamton will be a destination for talent, new business development and partnerships for commercialization of emerging technologies. Revitalized urban centers in Binghamton, Johnson City and Endicott will maintain the area's legacy and position it as a major gateway, with strengths in advanced manufacturing, healthcare, culture and high-technology development. Innovation Districts will capitalize on public-private collaborations and the growing presence of Binghamton University.



Invest in the Advanced Manufacturing Industry

A focus on advanced manufacturing and the transportation industry sector will result in the Southern Tier being recognized as a destination for manufacturing business development, distinguished by its concentration of multi-national anchor companies, advanced infrastructure to support innovation and technology, rich education and research resources, specialized skilled workforce and vibrant communities.



Transform the Food and Agriculture Industry

The Southern Tier will be a world-recognized leader in agriculture technology and serve as a key food supplier for the East Coast of the United States. Leveraging the global reach and strengths of Cornell University's College of Agriculture and Life Sciences, together with the region's natural assets and strong private sector investment, a strategic mix of projects will transform and grow

agriculture and food production, processing and distribution across the region, while also strengthening links to growing tourism and manufacturing industries.



Promote the Southern Tier's Innovative Culture

The Southern Tier will be a well-recognized and highly desirable place to learn, visit, live and grow a business because the region's distinct combination of educational strength, culture, innovation, leisure-related industries and natural resources creates a lifestyle that couples the convenience of larger cities with opportunities to lead a healthy lifestyle surrounded by natural beauty.

Advancing the Southern Tier's Strategic Initiatives in CFA Round V

The Southern Tier proposes thirty-three projects totaling \$30 million in ESD Capital investments to advance both the Governor's Initiatives and the region's industries with the greatest opportunity for *growth in jobs, wages, private investment, exports and foreign investment and industry clusters*. These industries include Health Care, Advanced Manufacturing, and Agriculture. The projects were deliberately selected to meet these objectives, but also to advance the region's new *Industry Cluster Plan* as well as the ongoing commitment to its *Opportunity Agenda Plan, community reinvestment programs and efforts to engage the hard-to-place workers*.

The cumulative project costs for these thirty-three projects is \$332,586,029, with an expected leverage of 11:1.

These priority projects are driven by a strong foundation of target industries, higher education institutions, the non-profit sector and government agencies. They are geographically disbursed throughout the eight counties, yet have the focus necessary to bring about measureable impact. Examples of signature projects include:

The City of Binghamton's Mixed Use Development at 7 Hawley Street is an anchor project in the revitalization of the city's urban core.

Binghamton University's project to redevelop the former industrial building at 48 Corliss Ave, in the blighted urban core of Johnson City to house its Decker School of Nursing, represents the first anchor in the new Health and Science Technology Park.

Regan Development's Century Sunrise Mixed-Use Redevelopment Project also is a key project in the Johnson City Health and Cultural District. It will stimulate other private investment around Binghamton University's new Health and Science Technology Park and meet the growing demand for rental housing in the area.

Masserson Properties, Inc. will create another exciting tourism destination in Delaware County with the Roxbury Stratton Falls project. Its unique themed lodging facility will attract major tourism traffic, particularly residents from the NYC metropolitan area and international travelers.

Anchor Glass, a major manufacturer in the I-86 Innovation Corridor, will be adding 36 jobs and upgrading a furnace to significantly expand its manufacturing capacity and grow glass product exports.

Cameron Manufacturing, located in the I-86 Innovation Corridor, plans to acquire property and build a 100,000 square foot addition to increase its manufacturing facilities and add 39 jobs; another important addition to the advanced manufacturing industry sector.

DeMets Candy, a foreign owned company in the I-86 Innovation Corridor near Elmira, and will be undertaking an \$18.8 million project involving a 100,000 square foot expansion an addition of 70 jobs.

Elmira College and Lake Erie College of Osteopathic Medicine are collaborating to bring a medical school to the college's campus. It will be a major driver in the revitalization of downtown Elmira.

Corning Community College and two private development companies have collaborated to build a unique Health & Education Complex on the site of the former Corning Hospital. Not only will it bring the college campus to the urban core, but also provide an innovative model of combining a mixed-use market rate housing development with a health and education platform.

The City of Ithaca and Cornell University are taking the first steps to revitalize the College Town area with the relocation of a firehouse and university buildings. It is an exciting project that will impact tourism, attract talent and be one of the first projects in the Promote the Southern Tier's Innovative Culture initiative.

Finger Lakes ReUse is undertaking a major renewable energy project with its *Building Innovation Through Reuse* project in Tompkins County.

- 1. General Economic Indicators
 - a. Private Sector and Public Sector

HOW MUCH DOES THE SOUTHERN TIER CONTRIBUTE TO THE UPSTATE ECONOMY?

The Southern Tier economy is Upstate's fifth largest in terms of jobs. The region's economy accounts for 7% of total jobs and nearly 6% of all firms in the Upstate area.

In comparison to its share of jobs and firms, the Southern Tier is performing on par in terms of total gross metropolitan output and over achieving in terms of global exports and proportion of jobs in STEM-intensive industries.

Gross regional production is on the rise, with an estimated increase in gross regional product of nearly 15% between 2011 and 2013. In 2013, the total gross regional product was \$28 billion, up from \$27.2 billion in 2012.


Exports grew to \$37 billion in 2013.


Despite employment losses to the high-export manufacturing industry, the region is still expanding economically.

Increase in number of small private firms. The increase in small firms compared to a decrease in large firms is an indicator of the strength of small business in the Southern Tier, as well as the growing and healthy entrepreneurial community. In the years since the recession, the Southern Tier has seen a net increase of 186 in the number of private firms. The majority of these firms were small, with less than three employees total. Net

firm growth between 2009 and 2014 varied by county; Broome, Schuyler, Steuben, Tioga, and Tompkins all had net growth, while Chemung, Chenango, and Delaware lost firms (QCEW, 2014).

It's important to note that Binghamton University is included in the public sector, while Cornell University is included in the private sector.



c. Workforce

With a labor force of 312,500, the region has the sixth largest labor market in Upstate. Over 23,000 (7.5%) of these people were without jobs in 2013. Moreover, 42% (over 227,000) of people (over age 16) are not in the labor force. This includes those who have disabilities, are retired, go to school full time, or have stopped looking for work. Bringing more of these potential workers back into the labor force is key to the region's economic future.

A shrinking labor force. Since 2000, the Southern Tier has lost 6% of its labor force, compared to growth at the state and national level (5% and 9%, respectively). Every county in the region, with the exception of Tompkins County, lost labor force over the same time period. Broome and Chemung lost the most, 10%, followed by Delaware, Schuyler, and Tioga each with 9% loss. As the labor force decreases in the region, it inhibits the ability of firms to fill available or new positions, and thus constrains economic growth.

• Long-term job loss. The region lost more than 16,000 jobs since 2000, with a loss of over 3,900 just since 2009. The Southern Tier lagged behind statewide job growth, as state jobs have increased by 6% since 2000. The Binghamton Tri-City area lost the most jobs, more than 12,500 and 16% of all current jobs, since 2000. Chenango, Schuyler, and Tompkins were the only counties to gain jobs over the decade, with Tompkins contributing a net increase of 2,150 jobs (NYS DOL).

d. Average Annual Employment


- Manufacturing, a bedrock of the Southern Tier economy, has lost 35% in employment since 2000 but continues to be the second largest employment sector behind health care. The manufacturing sector employs over 34,000 individuals, which represent 13% of all workers in the region.
- Transportation Equipment Manufacturing sector continues to be a
 powerhouse with location quotient of 8.9% and 70 anchor and supply chain
 businesses employing 11,000 workers throughout the region. It carries the
 highest average wage in the region at \$73,800. This cluster has the highest level
 of exports at \$4 billion in 2013.
- Food and Agriculture manufacturing employment is growing. The food and agriculture industry employs 4,762 individuals. Employment grew nearly 23% (884 jobs) between 2010 and 2014. The Southern Tier is home to more than 6,600 farms and possesses agricultural assets ranging from Cornell's commitment to the industry in Cornell Cooperative Extension to the thriving dairy industry. These advantages have allowed for growth in the region's agriculture and food manufacturing industry. Employment in food manufacturing has grown 41% since 2009 with over 1,000 net new jobs, while the food processing cluster increased employment by 18% over the same time period (UBRI). The location quotient for agriculture is 2.9, and combined with forestry it is 1.9, indicating a strong presence in the economy. Food manufacturing contributes nearly \$4 billion in exports to the regional economy, while crop and animal exports contribute over \$830 million (EMSI). The food and agriculture industry cluster also impacts the region's economy with a jobs multiplier of 2.33 and a sales multiplier of 1.70.
- Employment in service-related industries is rising. Between 2000 and 2014, employment in health care, arts and entertainment, and hospitality increased by 16%, 17%, and 18%, respectively. The two latter industries support the growing tourism industry in the Southern Tier, and are indicative of growth in this area. Other industries also expanded employment, including company management (7%), other services (10%), and agriculture (13%). Even though wages in these industries remain below the Southern Tier average (the highest average wage in the above industries is \$40,800 in health care, below the regional average of \$43,714) (NYS DOL), expanded employment opportunities still drives economic growth and is balanced by the lower cost of living.

MANUFACTURING IS STILL AN AREA OF STRENGTH

Manufacturing is still an area of strength for the Southern Tier in terms of institutional knowledge and employment.

- Employs 34,000 individuals.
- Contributes more than \$2 billion to the region in payroll each year.
- \$11.6 billion annually in exports.
- Location quotient of 2.5, with 8.9 LQ in the Transportation Equipment Manufacturing cluster.
- Average annual wage of \$61,800, which is 41% above the average for all industries in the region (\$43,700).
- Average annual wage in the Transportation Equipment Manufacturing cluster is \$73,800.

UNEMPLOYMENT DOWN IN POST-RECESSION YEARS


The Southern Tier's unemployment rate, at 6.1% in 2014, is slightly below state and national unemployment rates (6.3% and 6.2%, respectively). This is down from a 14 year high of 8.4% in 2010, during the height of the recession. All counties in the region have an unemployment rate between 6% and 7%, though Tompkins County had a lower unemployment rate at 4.3% in 2014 (NYS DOL).

- Lower average wage than the state. The average wage in the Southern Tier was just over \$43,700 in 2014, an 8% increase from 2010. However, this was below the New York State average wage of \$65,900. An additional challenge is that of the top five industries by employment in the Southern Tier, only two had average wages above the state (manufacturing and educational services). While the cost of living is lower in the Southern Tier than other parts of the state, the lower average wage earned for occupations in the Southern Tier is a barrier to attracting talent from outside of the state.
- Lower average wages in key population centers. The average wage in Binghamton across all industries was just over \$40,400 in 2014—below the average wage for the region and far below the average for the state. Elmira's average wage was on par with the regional average. Corning had the highest average wage of all the metropolitan areas at \$51,400, while Ithaca had an average wage of \$47,700. As with the region in general, competitive wages are essential for attracting talent and population to areas—an even more critical need for the Southern Tier's urban areas (QCEW, 2014). Manufacturing had one of the highest average wages in the Southern Tier at \$61,800 in 2014, 41% above the regional average of \$43,700.

e. Gross Regional Production

Gross regional production is on the rise, with an estimated increase in gross regional product of nearly 15% between 2011 and 2013. In 2013, the total gross regional product was \$28.2 billion (EMSI, 2013) and \$27,288,815,664 in 2012. These figures show that despite losses to the high-export manufacturing industry, the region is still expanding economically.

f. Value of Regional Exports and Change in Exports Value






a. Demographics

c. Poverty status of residents


The poverty rate is rising. The Southern Tier poverty rate was 16% in 2013, slightly above the state's 15%. This means that 16% of Southern Tier residents were living below the poverty threshold, held at \$23,800 for a family of four in 2013. Since 2011, the poverty rate has increased by just under one percentage point in the region, despite decreasing poverty rates in some counties, including Chemung, Delaware, and Tioga counties (ACS 09-13).

There were 60,965 residents living in poverty in the Southern Tier in 2013, with an average labor force participation rate of 46%, just below the 49% at the state level. The average unemployment rate among those living in poverty was 26%, compared to an unemployment rate of 8% for all socio-economic groups. Broome County and Tompkins County had the largest number of individuals living below the poverty line, 19,531 and 14,300, with unemployment rates 29% and 11% among this population, respectively. However, Tioga County and Chenango County have the highest rates of unemployment among those living in poverty, 36% and 31%. This is compared to the statewide rate of 30%.


The county rates described above reflect many persons living in rural areas; however, the highest concentrations of poverty are in the major urban communities of Binghamton, Johnson City, Endicott, Elmira, Norwich and Hornell.

d. **Migration** (% living in same region as previous year, % leaving NYS)

Movement out of the region. In every year since 2001, residents have migrated out of the Southern Tier. In 2014, 3.9% of the region's residents migrated outside of the Southern Tier, with the highest outward migration in Chemung, Tioga, and Steuben counties (8.4%, 6.9%, and 6.9%, respectively).

Movement into the region for select age groups. Chenango, Delaware, Tioga, and Tompkins counties all experienced slight growth in the number of residents under the age of 20 moving into the region from a different state, likely a reflection of the healthy higher education industry. However, Chemung and Tioga also experienced growth in the number of adults in the 20-39 and 40-59 age groups moving from other states, and Tompkins had an increase of 1.6 percentage points in the number of 20-39 year olds moving from abroad (Census Bureau, 2013). This shift may be an early indication that the loss of young people experienced by the region over the past few decades may be counteracted by movement into the region.



Movement into distressed areas. Chemung and Steuben counties, including the metro areas of Corning and Elmira, had 2.3% of total population move from out of state, second only to Tompkins County in the region and above the regional average. Though the populations in Hornell and Norwich are small, relatively large proportions of select age groups are relocating to these cities from other counties or outside the state. In Hornell, 6.2% of 20-39 year olds moved from a different county in New York and 9.7% did the same in Norwich—the highest proportions other areas in the Southern Tier. In addition, 5.9% of Norwich residents ages 20-39 moved there from out of state, second only to Ithaca's 8% in the region. Binghamton and the surrounding area continues to struggle in attracting population, with proportions of residents from other counties and other states lower than the regional average (ACS 09-13).

e. Commuting (% working in region of residence)

The Southern Tier is a rural region requiring a growing share of workers to drive alone to work. 77% of workers in the Southern Tier drive alone to work, which is slightly above the share for Upstate (76%). More are driving to work since 1990 when the region was on par with the Upstate benchmark of 73%. In terms of mode share, all alternative methods to get to work have declined except for public transportation, which has 2,500 more commuters than in 1990, a 45% increase in ridership.

There are several transit systems in the Southern Tier including Broome County Transit (Greater Binghamton), Tompkins County Area Transit (TCAT), the Steuben County Public Transit System and the Chemung County Transit System (CCTS) that also provides intercounty service to destinations including Corning, Watkins Glen, Ithaca and parts of Tioga County.

Though public transit ridership in the Southern Tier is up, it is not necessarily connecting workers to higher paying jobs. Workers who regularly commute by transit earn \$17,600 annually, or just over half of what workers who drive alone to work earn. This income gap compares unfavorably to state and national benchmarks where public transit users earn nearly the same as the average worker. This suggests workers with limited access to a vehicle, who live in areas where transit is accessible, are unable to reach higher paying jobs. Workforce development initiatives near employment centers and focusing growth near transit could expand economic opportunity to more workers in the region.

Public transit may not meet the transportation need for everyone. Carpooling has shown a 45% increase in ridership). Carpooling remains the most common way of getting to work besides driving alone, although fewer people share rides now than in 1990. A larger

share (6%) of workers bike or walk in the rural Southern Tier than Upstate at large (5%). In fact, though far fewer walk to work, the share of workers biking in the region has increased by over 50% since 1990.



Chemung and Steuben counties are piloting rideshare (carpooling) software. 511NY Southern Tier Rideshare is a free commuter and traveler information ride-matching service. The free website provides information on smarter travel options including carpooling, transit and bicycling. 511NY Southern Tier Rideshare is supported by Chemung and Steuben Counties, the New York State Department of Transportation and the Federal Transit Administration to provide. C-Tran, a mass transit provider, is part of the 511 service and provides a shopper shuttle between multiple malls in Chemung County, as well as commuter routes to Ithaca, Corning and Owego in Tioga County. There are additional ride-share programs in the region including Tompkins County Rideshare Coalition and Broome-Tioga Greenride.

VISITOR SPENDING


The Southern Tier is attracting more tourists every year. From the Corning Museum of Glass, which enjoys an estimated 440,000 visits a year and \$12.4 million in visitor revenue, to the Watkins Glen Racetrack, to the waterfalls of Ithaca, the region has a lot to offer tourists.

Visitor spending reached \$.87 billion in 2011, representing an 18% rise from where it was two years earlier – notably more than the 12% increase reported across Upstate, and on par with New York State's 18% increase. Tourism jobs have increased by 8% between 2009 and 2013, outpacing private sector employment growth which increased by less than 1% over this period. The average annual wage for this sector increased by 15% during the same time period. Adjusted for inflation, the increase was 5%, notably higher than the 1.5% overall dip in the region's private sector wages.

Visitor spending in the Southern Tier grew 18% between 2009 and 2011, outpacing Upstate trends.


Visitor spending on lodging, food services, transportation, recreation and retail reached \$0.87 billion in 2011, representing an 18% rise from where it was two years earlier. This increase is notably more than the 12% increase reported across Upstate, and on par with New York State's 18% increase in overall visitor spending. While the Southern Tier outperformed all other Upstate regions in growing visitor spending over this period, total visitor spending in the region represents a relatively small 6% of total visitor spending across Upstate and an even smaller 2% of the statewide total. *Source: Tourism Economics*

3. Key Regional Indicators

- **STEM-intensive industries are growing.** Scientific Research & Development Services and Data Processing, Hosting & Related Services both grew by over 88%. In the Southern Tier economy, STEM-intensive industries' share of jobs is 14.5% of all employment. Employment across all STEM-intensive industries declined by 10%; however, the region's STEM-intensive employment base still remains relatively strong and the average annual wage of \$72,308 in these industries remains very high compared to the regional average wage of \$42,235.
- The region has strong industry clusters, with a particular strength in manufacturing. The overall region's manufacturing sector employs the second highest number of residents, making up 13% of total workers in the region (above the 5% and 9% respectively for the state and nation). The location quotient for manufacturing is 2.5, indicating a concentration of manufacturing in the regional economy. In subsets of the manufacturing industry location quotients are higher; transportation equipment manufacturing has a location quotient of nearly 9, illustrating a long history of success in the region due to companies such as Corning Incorporated, Raymond Corporation, Borg Warner, Lockheed Martin, Dresser-Rand and others driving employment and exports. Manufacturing accounts for the most exports out of the region, over \$11.6 billion in 2013 (EMSI), nearly one third of total regional exports. The manufacturing industry boasts high annual wages at \$60,862 in the overall advanced manufacturing industry; and \$73,800 in the transportation equipment manufacturing cluster. In addition, the transportation equipment manufacturing cluster has a jobs multiplier of 2.46 and a sales multiplier of 1.68.
- Both goods and service providers are among the fastest growing and higher wage industries with Food Manufacturing growing the most. This industry cluster grew 41% or by 1,033 net new jobs between 2009 and 2013. The average wage is \$48,027, about \$5,800 a year higher than the regional average. Truck Transportation and Support Activities for Transportation were also among the region's fastest growing industries paying higher than average wages. Both grew nearly 20% in recent years. Overall, employment in higher wage industries fell by 3% between 2009 and 2013, while employment in lower wage industries grew 5%. This suggests growth supports may be needed most for higher wage industries as they better support a population that is economically self-sufficient and increase overall regional wealth.



Positive Trends and Opportunities


• Top industries have been adding jobs. Ten leading industries account for about half of jobs in the region. Although many are service providers related to food and beverage, there has been job growth in food manufacturing, education, health, and professional, scientific and technical services. Most of the region's top ten industries have added jobs since 2009. Although its employment declined slightly, the Educational Services industry remains a regionally significant source of jobs, exhibiting a larger than average share of employment when compared with the rest of Upstate. This is particularly significant with Binghamton University's goal to increase enrollment form 16,000 to 20,000 by 2020 and adding 250 faculty.

The region's economy also added a total of 1,595 jobs in the food & agriculture industry cluster between 2009 and 2013. Food manufacturing in particular was a leader, adding over 1,000 jobs. Additional industry clusters that are expanding include information technology, forest products and back office services.



- *Increasing diversity.* The Southern Tier is not as racially diverse as New York State, with 90% white residents compared to 66% at the state level. However, since 2000, the number of white residents has declined in the Southern Tier by 3%, and populations of African American and other racial/ethnic groups have increased by 24% and 30%, respectively, leading to a more culturally diverse population (ACS 09-13).
- Residential vacancy remains steady, the proportion of vacant housing units in the region grew just 1 percentage point since 2000, reaching 14% in 2013. This compares to a vacancy rate of 11% statewide. Vacancy rates have decreased in Hornell, Norwich and Elmira, and stayed flat in Corning at 15%. Binghamton's vacancy rate has increased to 11%, a 3 percentage point increase (ACS 09-13). The consistent vacancy rate indicates that the housing market suits the needs of the region, but has the flexibility to accommodate growth.

• Commercial vacancy rates declining in Greater Binghamton area. For the second quarter of 2015, the overall office vacancy rates for the Greater Binghamton area have declined from 14% in 2012 to 10.3%. In addition, the overall net rental rate for office space has also maintained a steady increase. With regard to industrial space in the area, vacancy rates hit their lowest point at the end of 2014 with a vacancy rate of 10%, a significant decrease from a high of 13% in 2011. Overall occupier activity of industrial space shows a significant increase in leasing activity and user sales activity in this sector.



High vacancy rates in job dense areas offer potential development opportunities.

Areas with high commercial vacancy rates tend to be concentrated near areas with the greatest employment density—Greater Binghamton, Elmira, Ithaca and Hornell. The Greater Binghamton area has a high concentration of jobs and contains 29% of the region's unused commercial spaces (651 vacant addresses). Elmira, Ithaca and Corning also have an abundance of unused commercial property. The City of Hornell, an anchor on the western portion of the region, has 53 vacant commercial addresses, 31 of which have been unoccupied for three years or more. Census tracts highlighted in yellow, orange or red have vacancy rates of at least 20%. Across the region, these account for 23% of all vacant commercial addresses. This abundance of vacant commercial space, in areas that are already developed, provides an opportunity for economic growth through reinvestment while preventing the costly consequences of sprawl.

- Overall wealth is increasing in the Southern Tier. Since 2009, the median household income of Southern Tier residents has increased by 8%, above the rate of inflation. In 2013, the median household income was just over \$48,000, compared to \$58,000 statewide. However, the state median income increased by just 5% over the same time period, indicating that growth is stronger in the Southern Tier than the state as a whole (ACS 09-13).
- **Education.** Adults age 25 and older in the Southern Tier Region have less education than their counterparts in Upstate, New York State and across the nation. Over half (55%) of adults in the region have at least some college education compared to a higher share (59-60%) across benchmark geographies. Although the Southern Tier has a smaller share of adults with a higher education, the region has a slightly lower percentage of high school drop outs (10%) than Upstate overall (11%). Nevertheless, those without a high school diploma typically face greater obstacles to finding higher wage jobs than their more educated counterparts.

- ✓ Highest proportion of students and graduates in the state. Of the Southern Tier's population, 13.2% are either undergraduate or graduate students, above the 10.2% statewide. In addition, due to the presence of Binghamton University, Cornell University, Corning Community College, Elmira College, Ithaca College, SUNY Broome, SUNY Delhi, and Tompkins-Cortland Community College, the Southern Tier is home to 4.5% of all students enrolled in the state, yet just 3.4% of the total population (Census Bureau, 2013). Of the 17,000 degrees granted in 2013, over 8,400 degrees were granted in the fields of business, engineering, education, health, social sciences, and liberal arts. These graduates fuel the workforce pipeline for many of the region's top industries which are related to health, administration and education. Local graduates can also help fuel industries with higher shares of aging workers, especially Educational Services. The Southern Tier's share of engineering graduates is higher than any other Upstate region—a comparative strength for the region. These graduates can support industries with a high potential for STEM employment, such as Electronic Instrument Mfg, which more than doubled in jobs from 2009 to 2013. However, as employment in STEM-intensive industries declined by 10% overall from 2009 to 2013, there may not be enough employment opportunities to keep these STEM graduates in the region. Retaining this young talent and aligning them with local employers could be a key to future economic prosperity in the region.
- ✓ Innovation. The region's innovative performance has grown, with higher levels of R&D, more patents, and more STEM graduates. Although jobs in the region's STEM-intensive industries declined in recent years, the innovative landscape for this region remains strong, according to key measures. Per capita R&D spending is up nearly 50% since 2000. Patents are also growing, up 24% since 2000. Meanwhile, 34% of graduates in the region are awarded a STEM degree—up from 22% in 2000 and 31% in 2010. While nearly a quarter or more of all STEM degrees and R&D expenditures across Upstate are generated in the Southern Tier, the region contributes notably smaller proportions to patents, new firms and employment at young firms. It is important to note that a portion of patents also are held by major companies such as Corning Incorporated with policies that limit spin-off activity.



Mapped Status of Past Priority Projects



C. STATUS OF ALL PROJECTS AWARDED CFA FUNDING

The Finger Lakes Tourism Alliance received \$210,000 in funding from Market NY to expand on its successful Wine, Water and Wonder marketing program. The project involves a collaboration among the Corning Museum of Glass, Finger Lakes Tourism Alliance, VisitRochester and Niagara Tourism & Convention Corporation. The program is targeting the international travelers already visiting New York City, and introduces them to the tourism destinations between NYC and Niagara Falls. The result is increased international visitor travel from China, France, Germany and the United Kingdom.

NYSERDA awarded a \$1,898,831 grant to Finger Lakes ReUse to develop a Community ReUse Center with Sustainable Tompkins and the Sustainability Center in Ithaca. The project includes development and construction of two building that will showcase the possibilities that can be achieved through sustainable design. The project demonstrates the benefits of collaboration, waste diversion, job skills training, revenue generation and job creation.

The Ithaca Tompkins County Transportation Council received a \$91,000 NYSERDA grant to conduct an Electric Vehicle Feasibility Analysis to create a plan for how best to install charging stations for electric vehicles in the County. This plan is the first step of a larger goal to stimulate a market shift from gasoline to electric powered vehicles to reduce greenhouse gas emissions.

Investments are being made by several different state agencies in targeted Opportunity Agenda areas of the older distressed communities such as Binghamton, Johnson City, Elmira, Norwich and Hornell. Examples include the Norwich Heritage Block Project, 72 Court Street in Binghamton, the Binghamton Gateway Project and Goodwill Theatre in Johnson City. This later project receiving funding in Rounds 2 and 3 from NYSOPRHP and HCR to renovate the historic Firehouse and Goodwill Theatre in Johnson City's Health and Cultural District.

I. Implementation Agenda

A. IMPLEMENTATION OF 2015 STATE PRIORITIES

New Strategies Adopted to Address State 2015 Priorities

Manufacturing Industry Cluster Plan

In 2015 the Regional Economic Development Council adopted a Manufacturing Industry Cluster Plan; specifically, on June 26, 2015, the REDC adopted a cluster plan focused on Transportation Products, Components and System Controls.

Since its inception, the Regional Economic Development Council of the Southern Tier has focused on job creation and economic growth strategies in the Transportation Equipment Manufacturing Sector. The region's strategic economic development plan adopted in 2011 states "the Southern Tier region is distinguished by innovative partnerships between academic centers and its manufacturing base. Cornell and Binghamton Universities offer nationally recognized programs of study and faculty, research and development centers, new technologies and business incubators. Global corporations offer the opportunity to productize next generation technologies, especially in energy and transportation."

In early 2015 the Southern Tier's REDC established an Industry Cluster Work Group assigned to re-examine the region's industry clusters and identify one manufacturing industry cluster that would have the greatest capacity to grow in terms of private investment, jobs and global exports going forward. The Work Group was assisted by Christian Harris of the NYS Department of Labor, Jim Held with Empire State Development and Matt Watson also with Empire State Development. In addition, Jim Cunningham, a Business Developer/Principal Consultant with the Alliance for Manufacturing and Technology served as an expert consultant to the work group.

The Industry Cluster Work Group undertook four tasks including of identifying the attributes of potential manufacturing clusters, analyzing data, assessing opportunities for growth, and identifying the cluster with the greatest opportunity for impact in terms of jobs, wages and global exports.

The Work Group arrived at the following conclusions:

Conclusion: The Southern Tier continues to have significant prowess in manufacturing and there is a strong potential to increase its role in the region's advanced economy of the future.

- ✓ Largest export industry in the region at \$11.6 billion annual and nearly 1/3 of all exports.
- ✓ Strongest location quotient at 2.54.
- √ 34,000 workers, representing the third largest employment sector in the Southern Tier economy, following government and education/health services.

Conclusion: In comparison to the balance of New York State, the Southern Tier region has the strongest manufacturing base among the ten regions and the associated cluster businesses. Although the Southern Tier's overall manufacturing industry saw a loss of 127 manufacturing businesses (17%) in the period 2000-2012, and a 33% loss of jobs between 2000 and 2013, there are several new and exciting dynamics that are influencing the future of manufacturing in the future.

Conclusion: Manufacturing has the expertise and partnerships in place to catalyze and support collaborative growth in emerging economic sectors, particularly in transportation, advanced materials, and food and agriculture. There is significant potential for the rapid product development in the quickly growing global market for advanced energy products as they apply to transportation manufacturing through an organized and intensely driven university-industry partnership focused on emerging technologies ranging from battery and energy storage and energy efficiency to renewable energy, flexible electronics, and hydrogen and fuel cells.

Conclusion: Critical Mass in the Southern Tier's Advanced Transportation Equipment Manufacturing Sector

The Brookings Institution recommends a focus on cultivating those advanced industries with strong regional industry clusters based on local specializations, as well as those with high-value export potential. These industries are characterized by high-levels of research and development and a heavy reliance on workers with science, technology, engineering, and math (STEM) skills. Based on further local analysis it was determined that within the Southern Tier's manufacturing industry there is particular strength in the Advanced Transportation Products, Components and Control Systems sector.

Conclusion: Based on data provided by the NYS Department of Labor, a further examination of employment trends and wages in each of these two clusters were considered, and Advanced Transportation exceeded the average annual wage in the Food and Beverage Manufacturing cluster by more than \$28,000.

Conclusion: The work group examined export activity of the two industry clusters in the context of total exports among the various industry sectors in the region, and concluded that both clusters had strong exports with Transportation at \$3.9 billion and Food & Beverage at \$3.1 billion.

Conclusion: In addition to employment and wages, the work group considered location quotients, which indicated that Advanced Transportation Products significantly lead the region's manufacturing industry with an LQ of 8.968, as compared to a LQ of 2.934 for the Food and Beverage cluster.

Action: Taking all factors into consideration, and the recommendation of the work group, the REDC concluded that Transportation Cluster has the greatest opportunity to leverage emerging technologies, generate exports and create jobs at a high wage. The REDC adopted a manufacturing industry cluster plan focused on Transportation Products, Components and Control Systems. The work group further developed a detailed plan that also is supported in the 2015 CFA round and URI Plan.

Southern Tier Strategies in Support of State Priorities: Progress to-date and Future Actions



Global Marketing and Export Strategy

During 2015 the REDC focused on increasing foreign investment in business expansion and new business development. The efforts paid off with plans by several foreign owned companies in the region executing plans to expand and continue with investments. Examples include:

- DeMet's Candy, a Belgium-based company has operations in the Elmira area. The company has plans to invest in a 100,000 square foot expansion with a total project cost of \$18.8M. The company also will add 70 jobs.
- Block Bindings in Greene, NY (Chenango County) also is a foreign owned company and will be acquiring property and equipment to
 expand its operations with a \$1.3M investment and 7 new jobs.
- Alstom Transportation, a French owned company, is planning a \$100M investment in Hornell to upgrade and construction facilities to manufacture a cutting-edge technology high-speed train.
 Additional investments will be made to create a High-speed Rail Hub and expand the supply chain.



Raymond Corporation, owned by Toyota of Japan, is planning construction of the Raymond Manufacturing Center of Excellence in Greene, NY to enhance and maintain its standing as a preeminent global manufacturer. The company also is committed to supporting the Regional Council's Opportunity Agenda by focusing on hard-to-place workers, particularly veterans.

Another high priority of the Council in 2015 was to advance an increase in export activity. Several companies in the region developed plans to invest in equipment and infrastructure to provide them with the capacity to increase production specifically for purposes of increasing the volume of exports. Examples include Corning Incorporated's Heavy Duty Diesel manufacturing operation that is exporting 50% of the products manufactured at its facility in Addison (Steuben County), and Anchor Glass that is planning a significant investment to upgrade its furnace and increase capacity at its Elmira production facility to increase the volume of products for both domestic consumption and exports.

Another important strategy for the Southern Tier is increasing international visitor spending by investing in key tourism destinations that attract The most significant project undertaken was completion of construction of the international large volumes of international visitors. motorcoach entrance at the Corning Museum of Glass in Corning, NY. The Southern Tier also understands the opportunities to increase marketing alliance activities to enter into new foreign markets and expand penetration into existing markets. Existing markets include Germany, United Kingdom and China; while new markets consist of countries such as France, Russia, Argentina, Brazil and Israel.

Innovation Hot Spot

The Southern Tier Regional Incubator Plan, adopted by the Council in 2013, is a partnership comprised of SOUTHERN TIER

Binghamton University, Corning Incorporated, the Ceramics Corridor, and Cornell University as the Startup Alliance Southern Tier's Innovation Hot Spot (STIHS). This entity received both designation as the Southern Tier's Vital resources for entrepreneurial growth Innovation Hot Spot and incubator funding under the 2013 CFA. The new regional Hot Spot is bringing

together the contributions of incubators and entrepreneurial support structures in the region, which include and includes 6 regional business incubators: The Center, IncubatorWorks, the McGovern Center for Venture Development in Life Sciences, Rev: Ithaca Startup Works, and the Startup Suites at Binghamton University.

The Southern Tier Innovation Hot Spot began operation on January 1, 2014 with funding from CFA Round 3. The combined incubators have 21 member / tenant companies. In 2014, the Southern Tier Innovation Hot Spot was renamed the Southern Tier Startup Alliance (STSA) and began offering startups and entrepreneurs in the region business support through mentorship and skill-building workshops. In 2014, STSA Entrepreneurs-in-Residence met with over 350 entrepreneurs and startups in the partner incubators and throughout the region, spending over 750 hours on mentoring. The STSA has made significant progress toward its goal of holding at least one workshop in each of the region's 8 counties, and expects to achieve this goal by December of 2015.

In addition, the STSA's Small Business Administration-funded Hardware Accelerator completed its pilot round in the summer of 2015 at Rev: Ithaca Startup Works, putting nine startup teams through a 12-week rapid prototyping program that leverages our region's strengths in manufacturing and excellence in business mentoring.

In the future, hardware entrepreneurship will continue to be a focus as the STSA develops its Hardware Entrepreneurship Ecosystem, which is funded in part by a \$500,000 Economic Development Administration i6 Challenge Grant. The STSA also plans to hold a second round of the Hardware Accelerator program in the summer of 2016. More generally, the STSA will continue to increase the number of entrepreneurs supported by entrepreneurs-in-residence and workshops, as well as playing a key role in the new 76West initiative.

NY Rising

The NY Rising Community Reconstruction (NYRCR) Program was established to provide rebuilding and revitalization assistance to communities damaged by Hurricane Irene, Tropical Storm Lee, Superstorm Sandy, and the summer floods of 2013. The NYRCR Program is enabling 124 severely impacted communities to undertake projects and other needed actions based on community-driven plans that consider current damage, future threats and economic opportunities.

In the Southern Tier, the NYRCR Program supported the development of several Community Reconstruction Plans, each laying out specific strategies and implementation projects. These plans are directly linked to numerous strategic objectives of the Southern Tier's Regional Economic Development Plan, as outlined in the ST REDC's 2014 Progress Report.



In the Southern Tier, 14 municipalities in 3 counties are participating in the NYRCR program.

- <u>Tioga County</u>: The Town of Nichols, Village of Nichols, Town of Owego, Village of Owego and Town of Tioga have prepared a collaborative NY Rising Community Reconstruction Plan and are eligible for up to \$15,000,000 in Federal Community Development Block Grant-Disaster Recovery (CDBG-DR) Implementation Funds.
- Broome County: The City of Binghamton, Town of Union, Town of Conklin, Town of Vestal, Village of Johnson City and Village of Endicott have completed a collaborative NY Rising Community Reconstruction Plan and are eligible for up to \$18,660,947 in CDBG-DR funds. Additionally, the Town of Chenango was added to the program in early 2014 and is eligible for up to \$3 million in CDBG-DR funds.
- <u>Delaware County</u>: The Villages of Sidney and Margaretville each have completed Community Reconstruction Plans and are eligible for up to \$3,000,000 each (\$6,000,000 total) in CDBG-DR funds.

Rising to the Top Awards

In addition to being eligible for over \$42,000,000 in federal implementation funds, the Southern Tier received 2 of 8 statewide competitive NY Rising to the Top awards announced by Governor Cuomo in April 2014. The Broome, Tioga and Sidney communities were awarded \$3,000,000 for Regional Collaboration and Margaretville was awarded \$3,000,000 for Community Involvement. These awards bring the total amount of CDBG-DR funds available for implementation to over \$48,000,000.

Implementation

During 2015, work began on 17 Southern Tier projects that will result in a total investment of nearly \$22 million in federal CDBG-DR funds. While full construction will not be completed until 2016 for most of the projects, engineering and design will be well underway by the end of 2015 for many of the following projects.

Coordination between NYRCR and REDC

Revitalization of Southern Tier communities impacted by Hurricane Irene and Tropical Storm Lee is a high priority of the ST REDC. In fact, the ST REDC first developed several of its successful programs (e.g., community revitalization fund and rural ventures fund) to help these and other distressed communities become more resilient. Representatives of the NYRCR Broome, Tioga, Sidney and Margaretville Communities have communicated regularly with the ST REDC to ensure that they are pursuing mutually shared goals and objectives. Several NYRCR committee members also serve on the ST REDC, thus providing continuity between the two entities. The REDC and its members, along with the REDC's State Agency Resource Team (SART), have been briefed regularly on the NYRCR program, progress and priorities. Many of the NYRCR strategies and projects align closely with those of the ST REDC.

Due to the fact that the Southern Tier NYRCR Plans identify nearly 180 projects at a total cost (\$266 million) far in excess of the federal funds available through the NYRCR program, it will be critically important to maintain a close working relationship between the Southern Tier communities and REDC, as well as with the SART. Several flood recovery or resiliency projects were funded through last year's CFA round. This year, numerous applications that support revitalization in NYRCR communities were submitted under the Round 5 CFA. While most of these projects were not specifically identified in the NYRCR plans, they nevertheless are consistent with the economic and flood resiliency strategies outlined in the plans.

Local Government Efficiency Assistance

Municipal is an essential component of economic development. Municipalities cannot continue with "business as usual" if unsustainable spending makes firms nervous about escalating property taxes or even the potential for takeover of local finances by the State. The STREDC continues to work with communities and the SART to create efficiencies and position communities to support economic growth. Recent Local Government Efficiency (LGE) projects that involve municipal restructuring in the Southern Tier include:

- Chemung County and the City of Elmira entered into an innovative agreement to transfer the City's Department of Public Works staff to the County. The City will now contract with the County for highway services, which will allow the City to shed long-term obligations for employee pensions and health care costs.
- Schuyler and Yates counties conducted a feasibility study to explore shared services and even the possibility of a merger. While a
 merger was considered too difficult to accomplish, several tax-saving opportunities are under discussion. One innovative proposal
 under consideration by both legislatures is a jail facility that would serve both counties.

SUNY 2020



The most significant set of initiatives for the Southern Tier in the SUNY 2020 plan involve the development of the Health and Science Innovation Technology Park being undertaken by Binghamton University. The Regional Council understands the importance and long-term economic impact of this plan, and made projects that would support it a priority in 2014 and 2015. BU's SUNY 2020 plan includes construction of the new Pharmacy School and relocation of the Decker School of Nursing to a highly distressed area of Johnson City. The Council made it a priority to support this project, as well as other projects that will be critical to the success of

the SUNY 2020 plan and revitalization of Johnson City's urban core. These include the 59 Lester Ave project to redevelopment a 10-acre site in a designated BOA; as well as revitalization of historic buildings to house the Goodwill Theatre and renovation of a large, vacant industrial building to create a mixed use development on Baldwin Ave, located directly adjacent to the new Pharmacy School.

Cleaner Greener

The Southern Tier adopted an extensive and detailed plan in 2013. The region has been particularly successful in making progress in the implementation of its Cleaner Greener Plan. Action items described below only represent a small portion of actual tasks completed, and several projects to continue advancing the plan already are in the que for 2016.

- NY Prize Microgrid Feasibility grants were awarded by NYSERDA to the following Southern Tier Communities:
 - Tompkins County (for a microgrid centered around the Ithaca-Tompkins County Airport, Village of Lansing) (Tompkins)
 - o City of Ithaca (Tompkins)
 - Village of Endicott (Broome)
 - o City of Binghamton (Broome)
 - Village of Sherburne (Chenango)
 - Village of Bath (Steuben)
 - o City of Elmira (Chemung)

- Tompkins County Cornell Cooperative Extension, the Tompkins County Chamber of Commerce and TAITEM Engineering have established the *Tompkins County Commercial Energy Efficiency Collaborative* to encourage energy efficiency in commercial buildings. (Tompkins)
- The *Ecovillage Passive House Neighborhood* is slated for completion in Fall 2015 with one of the largest concentrations of passive houses in North America. (Tompkins)
- Lighting replacement has been undertaken for the Boys and Girls Club in Endicott Town of Union and the YWCA in Binghamton is developing an energy efficiency plan for the downtown area and their building has become very energy efficient after a recent renovation. (Broome)
- In Chenango County, the CCIDA Industrial building renovation, Warren Eaton Airport installed heat-exchanging makeup air units and NYSERDA-approved lights, the Sherwood Hotel in Greene installed approx. 20 high-efficiency split-system heat pumps, and the Town of Greene installed high-efficiency furnaces, NYSERDA-approved lighting in the Town Hall.
- Tompkins County and the City of Ithaca have approved PACE Financing through Energize NY, and Tompkins County anticipates completion of its Energy Road Map by the end of 2015. The Road Map will outline renewable energy and energy efficiency potentials in Tompkins County and develop a preferred scenario to achieve the County's goal of an 80% reduction in greenhouse gas emissions by 2050.
- A 2030 District is being established in the City of Ithaca and Tompkins County will be a charter member including several downtown County buildings. The District received a Cleaner Greener Planning Grant from NYSERDA. (Tompkins)
- Tioga County has conducted facility improvement measures, including updating lighting, enveloping buildings, and replacing roofs, among others, on all seven county buildings.
- The Steuben County DPW uses grazing animals (sheep and goats) at the closed Bath landfill to eliminate mowing 4 times a year.
- Cornell University has installed a 2 MW solar farm on university property adjacent to the Ithaca-Tompkins Regional Airport, and design is underway for a 3 MW solar farm at Broome County Airport and Landfill.
- The cities of Binghamton and Ithaca have installed Binghamton solar-powered parking meter systems.
- Southern Tier Solar Works 2014 pilot program generated 47 residential solar installations totaling 385kw through its community group purchasing program, and has generated 58 residential installations totaling 537kw to date. This program also promotes residential and small commercial energy efficiency and is funded through CGC to continue through January 2018.
- The Ithaca Area Wastewater Treatment Plant will utilize its anaerobic digester as part of the City of Ithaca Microgrid Feasibility Assessment, and the Bath Wastewater Treatment Plant will utilize an anaerobic digester as part of a resource recovery hub, in addition to smart grid technology and 5 MW of solar.
- Warm Up Tompkins is setting up a network of homes that converted from heating oil or LPG to heating with wood pellets.
- The Southern Tier Rideshare Program is now operational in collaboration with Chemung County, and Steuben County was chosen as a rural pilot program. In addition, Ithaca Carshare has expanded with the addition of new hybrid vehicles.
- The City of Ithaca and the Tompkins County IDA are updating the Community Investment Incentive Tax Abatement Program that incentivizes dense infill development in designated areas in the City.
- Tompkins County in collaboration with Better Housing for Tompkins County received a CDBG grant to provide for essential health-impacting housing improvements and energy efficiency upgrades for low to moderate income homeowners. (Tompkins)
- Steuben County, in collaboration with Arbor Housing and Development, uses CDBG funds to repair and replace malfunction septic systems and water supplies for low to moderate income homeowners.

B. IMPLEMENTATION OF KEY REGIONAL PRIORITIES

New Regional Initiatives

The ST REDC adopted one new regional priority in 2015; that is, the Industry Manufacturing Cluster Plan that is described on page 73.

As a result of the Upstate Revitalization Initiative planning process, the Southern Tier REDC adopted four new initiatives that will drive its next 5-year plan to build an advanced economy. The plan includes the following four initiatives. The strategic plan for deploying these initiatives are outlined in the Southern Tier URI plan to be submitted on October 5, 2015.



Build the Greater Binghamton Innovation Ecosystem

Greater Binghamton will be a destination for talent, new business development and partnerships for commercialization of emerging technologies. Revitalized urban centers in Binghamton, Johnson City and Endicott will maintain the area's legacy and position it as a major gateway, with strengths in advanced manufacturing, healthcare, culture and high-technology development. Innovation Districts will capitalize on public-private collaborations and the growing presence of Binghamton University.



Invest in the Advanced Manufacturing Industry

A focus on advanced manufacturing and the transportation industry sector will result in the Southern Tier being recognized as a destination for manufacturing business development, distinguished by its concentration of multi-national anchor companies, advanced infrastructure to support innovation and technology, rich education and research resources, specialized skilled workforce and vibrant communities.



Transform the Food and Agriculture Industry

The Southern Tier will be a world-recognized leader in agriculture technology and serve as a key food supplier for the East Coast of the United States. Leveraging the global reach and strengths of Cornell University's College of Agriculture and Life Sciences, together with the region's natural assets and strong private sector investment, a strategic mix of projects will transform and grow agriculture and food production, processing and distribution across the region, while also strengthening links to growing tourism and manufacturing industries.



Promote the Southern Tier's Innovative Culture

The Southern Tier will be a well-recognized and highly desirable place to learn, visit, live and grow a business because the region's distinct combination of educational strength, culture, innovation, leisure-related industries and natural resources creates a lifestyle that couples the convenience of larger cities with opportunities to lead a healthy lifestyle surrounded by natural beauty.

Implementation of Existing Regional Strategic Objectives

During the first four years the Southern Tier has made substantial progress in achieving results in its strategic objectives. Following are just a few examples of measurable and significant progress in implementation of the region's strategies.

Strategy 2. Manufacturing and Transportation Industry ... Next Generation Technology and Advanced Manufacturing

- <u>Strengthening the Southern Tier's Manufacturing Industry</u>: Pacemaker Steel in the City of Binghamton has acquired new equipment and expand their manufacturing facility to accommodate business growth. This project also is in a targeted Opportunity Agenda zone. The total cost is \$1,115,000, of which \$223,000 is an ESD Capital grant.
- Meeting Global Demand for Transportation Equipment Products Through Advanced Manufacturing



The Corning Heavy Duty Diesel project was completed in 2014, and the \$250 million, 90,000 square foot addition was officially opened in 2015. The company now has the capacity to meet global demand for emission control equipment. A total of 250 new jobs have been created. ESD capital of \$500,000 and Excelsior \$2.5M would critical funding sources to make the project successful.

Hilliard Corporation received a Round \$145,000 to purchase machinery and equipment, creating 15 new jobs and leveraging \$620,616. The new "Pleater" equipment is enhancing Hilliard's global competitive positioning and increase exports.



Strategy 4. Revitalize the Rural Farm and Forest-based Economy

• <u>The Southern Tier's Rural Initiative Fund</u> was established in Round 1 and has been a resounding success in building the agriculture and forest industry. A total of \$4,391,421 in loans have been issued, leveraging \$5,246,764 in other sources of project financing. The result has been creation of 156 jobs, retention of 25 jobs and an increase of 443 acres in production.

Strategy 5. Economic Development Backbone

- <u>Tourism:</u> The Corning Museum of Glass received funding in Round 3 to construct an International Visitor Motorcoach Entrance. CMoG is the most visited art museum in New York State outside of Manhattan, and is a major force in the upstate tourism economy with visitations exceeding 440,000 annually. The museum successfully completed the project involving a 100,000 square foot addition. The \$65,500,000 expansion project has resulted in the creation of 35 new jobs.
 - Lodging also is a critical element of growing the tourism industry in the Southern Tier. An example of an anchor lodging project is the Day's Inn Project in Corning. The project involves the demolition of a distressed 56 room hotel and adjacent bakery. Demolition was completed in 2014 and construction of a new 5-story, 125 room Hilton Garden Inn began in 2015. The new hotel will be within walking distance of the Corning Museum of Glass, Corning Incorporated's world headquarters, and Corning's historic Market Street. The \$14 million project will create 40 new jobs, and leverages \$12 million in private investment.
- <u>Broadband Initiatives</u>: The Southern Tier Network (STN) received \$5M in Round 3 to continue the extension of a 250-mile open access dark fiber backbone through Tioga and Broome Counties. It is being extended into targeted business development areas, and will be key to the effectiveness of the Southern Tier Innovation Hot Spot that requires high speed access for the universities.
- Global NY: Binghamton University Global Innovation Center is a Round 4 project that is well underway. The University broke ground and facility renovations are underway to establish a new Global Center to house international student support programs and services. It also will establish space for international classes. The project will be complete in June 2016 and create 124 jobs.
- <u>Community Reinvestment</u>: Community revitalization is a key element of the Southern Tier's Economic Backbone Strategy. Several priority projects funded in Rounds 2, 3 and 4 are having measurable impacts on the vitality of several communities. For example:
 - ✓ The former Watkins Glen Middle School in downtown Watkins Glen is being renovated by SEPP to create 50 low-income apartments for people 55+. A \$900,000 CFA Round 3 award is leveraging \$11M.
 - ✓ Arbor Development converted a former 1930's car dealership facility into a dynamic commercial office space in Corning NY. The new downtown commercial space was recently completed and quickly leased.

Strategy #6. Technology Development and Transfer ... A Job Generator

- Commercializing Technology and Promoting Entrepreneurs: In 2013 the Regional Council adopted a Regional Incubator Plan designed
 to bring together the innovation assets of Cornell University, Binghamton University, the Ceramics Corridor and major corporate entities
 such as Corning Incorporated and Lockheed. All four anchor hubs are off and running with ESD Capital awards in Rounds 3 and 4. For
 example:
 - ✓ The Incubator Works facility in the former Schweitzer facility in Chemung County will attract new business startups and bring jobs to the region through a collaborative effort, led by Alfred Technology Resource Inc., and supported by STEG and the Chemung IDA. It will provide efficient, functional and quality manufacturing space for startups. The project will create 50 jobs. The Round 4 ESD grant award of \$300,000 will contribute to the total project cost of \$1,560,000. The project is underway.
 - ✓ Cornell University received an ESD Capital grant award of \$1,000,000 in Round 3 for development of the Downtown Ithaca Incubator. It involves renovation of a 9,000 square foot building in downtown Ithaca to house the Cornell node of the Southern Tier's Hot Spot. The incubator focuses on start-ups based on technology transfer and commercialization, and supports student-founded companies. The first floor is complete, and a grand-opening took place in early 2015. The upper stories are currently under construction.
 - ✓ A Round 3 ESD Capital grant of \$925,000 was awarded to Binghamton University to renovate and equip new laboratory space to house an innovative research program for entrepreneurial students in high tech sectors. The total project cost is \$7,500,000, and it will generate 27 new jobs.

Strategy #7. Opportunity Agenda

Several projects are being undertaken with CFA Rounds 3 and 4 funding to promote the STREDC's Opportunity Agenda. For example:



The First Ward Action Council in Binghamton received a Round 4 CFA award of \$470,000 in ESD Capital funding to undertake the Binghamton Gateway Mixed Use Building project in the most distress area of downtown Binghamton. It involves complete revitalization of a critical mass of distressed properties including acquisition and rehab of 11 sites along Front Street and construction of a 3-story mixed use building on Clinton. Renovation is underway at this time.



II. Work Groups

A. WORK GROUP ACTIVITY

The Council's Work Groups have been actively engaged in many of the Governor and Council's initiatives. For example:

- Tourism Work Group: REDC continues to make tourism infrastructure development a priority because of its important role in recruiting talent in the future and an ideal tool to promote the region to prospective residents. This work group closely examined the importance of tourism in promoting the region to prospective workers and residents, investors and visitors; particularly the international visitors. The Tourism Work Group made several recommendations, including the creation of a tourism institute that would provide training and issue certification as a destination for international travelers. In addition, the work group recommended the development of a program that would attract young entrepreneurs to the tourism industry, as well as a program focused on revitalizing main streets so they are attractive to visitors, especially those that promote the "authentic" main street theme.
- ➤ Opportunity Agenda Work Group: The Veteran Work Group, Workforce Work Group and Opportunity Agenda Work Group discussed ways to engage the hard-to-place worker in the proposed Upstate Revitalization Plan. The work group recommended emphasis be placed on the distressed communities, and that the private sector must be involved in active recruitment and training. The community colleges will play a critical role in the future. SUNY Broome, for example, has come forward with several recommendations and plans including the development of new programs that support the projected growth in the healthcare industry in the Greater Binghamton area with upcoming plans for Binghamton University's new Pharmacy School and creation of the Health and Science Innovation Park in Johnson City. In addition, several colleges are collaborating to create an on-line repository for students and veterans to learn about internship opportunities in the private sector.
- ➤ Energy Work Group: The Energy Work Group was particularly active this year and engaged in several meetings to identify ways to increase employment in the energy sector, as well as infusing energy efficiency and technology in REDC projects at all levels. The work group produced a detailed set of recommendations that were shared with other appropriate work groups and considered as new projects were identified through the project pipeline for CFA Round 5. The work group focused on smart energy, as well as ways the Southern Tier to utilize the Hot Spot and 76West to promote the development of energy technology.
- Agriculture Work Group: The Agriculture Work Group also was very active in developing a detail plan for the growth of the food and agriculture industry in the Southern Tier. The group assessed the impact of the food and agriculture industry sector in terms of economic impact and niche opportunities. The work group recommended the Southern Tier's strategy include four components: technology development, investments in both production and processing, and development of a strategy for wholesale distribution hubs because of the region's highway system and proximity to markets.
- ➤ Global NY Work Group: The Southern Tier's Global NY Work Group considered the trends in export activity, and determined that there has been a growth in five of the eight counties in the region. It was recommended that the REDC continue to implement to recommendations made the work group plan issued in 2014, and that the REDC place a high priority on providing funding support to both companies that seeking to expand export activity and those that are foreign owned and plan to increase the level of foreign investment. Examples include Alstom, Raymond Corporation and DeMet's Candy.

Industry Cluster Plan Work Group: The Industry Cluster Plan Work Group was appointed by the Council in the spring of 2015 and charged with assessing and recommending a manufacturing industry cluster. Following analysis of data, assessment of impact and opportunity for growth, the work group recommended to the REDC that the Transportation Products, Components and Control Systems cluster be adopted. The detailed plan is discussed on page 93.
