Introduction – Stuart Rabinowitz:

Stuart opened the meeting promptly at 3:00 PM

Kevin Law:

Kevin concluded the overall presentation with an update on Governor Cuomo's Downtown Revitalization Initiative (DRI), currently in its third year. Participating communities are nominated by the state's ten Regional Economic Development Councils. Each community is awarded \$10 million to develop a downtown strategic investment plan and implement key projects that advance the community's vision for revitalization. On Long Island, 23 applications were received for this year's round of competition.
