Southern Tier Regional Economic Development Council 2018 Annual Report Assessment

I. Performance

a. Impact on job creation and retention

Strengths

- Total regional wages are up since 2011 in nearly every cluster of interest (advanced manufacturing, transportation equipment, food/agriculture, life sciences, and tourism). For example, total wages increased by 4.3 in the Transportation Equipment cluster between 2011 and 2017, while total job count decreased by 7 percent.
- The Life Sciences cluster had a 2.3 percent increase in average annual employment (AAE) from 2016-2017, and the Food and Agriculture cluster had a 1.5 percent increase.
- From 2012 2017, Priority Projects are projected to have retained 16,589 jobs and created 2,335 jobs.

<u>Weaknesses</u>

- The region continues to lag the state in key metrics. As of 2017, the regional unemployment rate was 5.4 percent, as compared to a statewide unemployment rate of 4.7 percent. Unemployment among working age individuals without a high school degree is much higher than the state average and the labor force participation rate of 58.1 percent is low and falling.
- The Advanced Manufacturing cluster had a 1.1 percent decrease in AAE from 2016 2017.
- Average annual private employment decreased by 0.3 percent 2016 2017.

b. Business growth and leverage of private sector investments

Strengths

- Between 2011 and 2017, the number of private establishments in the targeted cluster for the region increased 8 percent. For example, the number of Transportation Equipment firms increased by 8 percent.
- The Gross Regional Product is rising after a decline from 2014 to 2015.
- The ratio of total project cost to total ESD Capital Fund awards for all Priority Projects in the past seven rounds was 6.7 to 1 (excludes cancelled or declined projects). When considering all CFA projects (including Priority Projects), the ratio was 5 to 1.

<u>Weaknesses</u>

• The Southern Tier's workforce continues to shrink, and exports continue to slip.

II. Progress

a. Implementation of regional strategies described in a previous REDC plan and plan updates

Strengths

- The Region appears to be closely focused on the implementation of its four major strategies in its Upstate Revitalization Initiative Plan through game changing projects such as the Greater Binghamton Fund, the Unison Industries Expansion, or the Imperium3 Battery Consortium.
- The Southern Tier has experienced considerable growth in visits, tourism employment, and tourist spending. The strong commitment towards downtown revitalization is likely to make the region a more desirable destination.

<u>Weaknesses</u>

• None noted.

b. Execution of strategies that address state priorities or emerging state challenges and opportunities

<u>Strengths</u>

- Incubators are a major component of regional economic development strategies, with many inter-regional partnerships between Cornell, Ithaca College, and SUNY Binghamton. Already companies created through incubation have created 94 jobs and raised \$65.2M in venture capital.
- The STREDC continues strong support for advanced manufacturing, particularly in its cluster of Transportation Equipment. Their strategies include increasing the commercialization of technology, promoting job growth within the cluster particularly for high-skill high-paying occupations, supporting workforce training to maintain a skilled workforce, and increasing exports.
- The region is responding to challenges associated with dispersed poverty through a combination of workforce development, community development, and stakeholder outreach. These efforts have involved regional community colleges, BOCES, and Department of Labor training grants.

Weaknesses

• The Life Sciences Cluster is small compared to most other regions.

c. Success in workforce development initiatives, including engagement of hard-to-place workers

<u>Strengths</u>

- The STREDC has stressed the importance in developing apprenticeship programs through its community colleges.
- The STREDC is working to connect veterans with employers, support, and services including higher education, and to encourage the development of veteran-led businesses. While it may be in part due to an improving economy, these efforts are reflected in a significant reduction in the veteran unemployment rate from a high of 9.7 percent in 2013 to 6.9 percent in 2016.

<u>Weaknesses</u>

None noted.

d. Advancement of projects that revitalize downtowns

<u>Strengths</u>

• There is an extremely strong commitment towards downtown revitalization both as a regional strategy (*Build the Greater Binghamton Innovation Eco System*) and with projects being done in tandem with the Downtown Revitalization Initiative (DRI). The region is interested in making use

of other grant programs on both the state (HCR Mainstreet) and federal level (Opportunity Zones) to advance these priorities.

• Twelve of the proposed 2018 ESD Priority Projects and 15 other projects are listed as having a downtown revitalization component. Among the projects supported is construction by the Lake Erie College of Osteopathic Medicine (LECOM) of a new medical training facility within the Elmira DRI boundary that will eventually accommodate 480 students.

Weaknesses

• None noted.

e. Advancement of prior round Priority Projects

Strengths

- The Southern Tier has a track record for completing priority projects which underscores a tendency to support strong projects, both through the REDC competition and the Upstate Revitalization Initiative, such as the Binghamton University School of Pharmacy.
- 75.6 percent of all priority projects (112 of 148) and 84.7 percent of all CFA projects (173 of 288) are completed or on schedule. Only 6 percent of priority projects awarded (9 out of 148) have been cancelled or funding was declined.

<u>Weaknesses</u>

• None noted.

III. Planning

a. Quality of the Annual Report

Strengths

- The report is well written, ascetically pleasing, and organized in an intuitive manner.
- The report addresses the region's URI progress through the use additional performance metrics and success thresholds.

Weaknesses

• Little information was provided about the progress of past Priority Projects.

b. Ability to take the next steps in growing the regional economy

<u>Strengths</u>

- There is a strong support for incubators for both the retention of college grads, and the commercialization of technology with, as of 2017, 90 companies in regional incubators with \$65.2M in raised capital.
- The 76West Clean Energy Competition continues to grow the clean energy ecosystem in the region, having given \$10M in prizes since its inception.

<u>Weaknesses</u>

- The region has an aging workforce, falling exports, and stagnant economic growth.
- The regional poverty rate is 16.6% compared to a state rate of 15.7%. This is an increase from a rate of 15.4% in 2015.

c. Coordination with institutions of higher learning to address regional workforce development needs

Strengths

- There is coordination between both major regional employers such as Corning and community colleges to better meet workforce needs.
- There is considerable effort to retain college graduates from the region's universities through the Greater Binghamton Innovation strategy and the numerous incubators linked to Cornell.

Weaknesses

• There is still great difficulty of providing workforce development opportunities in the more rural parts of the region which often have the greatest need.

d. Collaboration with local governments in advancing opportunities for improved efficiency

Strengths

- There is considerable local outreach within the regional council.
- The STREDC recommended a project to implement countywide shared services plans, providing ongoing support to a new wastewater treatment partnership.

Weaknesses

• None noted.

IV. Proposed Projects

a. Solicitation and development of proposed projects that advance the regional economic cluster

Regional Economic Cluster

Advanced manufacturing industry with a focus on the transportation industry

<u>Strengths</u>

• The report indicates that 10 out of 29 proposed Priority Projects would advance the regional cluster. For example, Amphenol will support the transportation manufacturing sub-cluster by refitting and reutilizing a vacant facility in Endwell as part of a push to insource manufacturing operations.

Weaknesses

• None noted.

b. Identification of proposed projects for 2018 to advance State and regional priorities

<u>Strengths</u>

- The STREDC supported 2 priority projects to aid in the growth of the Life Sciences sector.
- The Advanced Manufacturing sector is supported by 10 priority projects.
- The STREDC supported 7 priority projects to aid in the growth of the Agriculture and Food Production sector, such as the Willow Run Food cooler storage addition which will create 40 jobs.
- The Cornell University Innovation Hotspot business incubator, Rev Ithaca, is supported for funding through the ESD Regional Hot Spot program.

- The STREDC supported 19 projects to advance strategies to make the regional economy more inclusive. For example, Ithaca Community Childcare will expand its facility to provide childcare to 60 more school-age children per day and around 50 more children not yet in school.
- The STREDC supported one veterans' project, the Broome County Veterans Complex.
- The STREDC is continuing to implement its strategy to "Promote the Southern Tier's Innovation Culture" through support of 6 priority projects.

<u>Weaknesses</u>

• None noted.

c. Advancement of proposed projects for 2018 to meet workforce development needs

<u>Strengths</u>

• The STREDC is addressing workforce issues through multiple strategies ranging from soft-skills training, veteran outreach, industrial apprenticeships, improved curriculum, and business incubators. Twenty-one of the proposed 29 Priority Projects listed as having a Workforce Development Component.

Weaknesses

• None noted.

V. Participation

a. Engagement of the community, public, and other stakeholders in the Regional Council process

Strengths

• The Regional Council cited frequent work groups meetings that allow people from the private, public, and non-profit sectors to participate in the Regional Council process.

Weaknesses

• None noted.

b. Regional unity and support of the Annual Report

Strengths

• Despite the rural nature of the Region, the Southern Tier has a good spread of Priority Projects throughout its boundaries.

Weaknesses

• There were no recommended Priority Projects in Tioga County.
