

Eight years ago, our communities came together to conceive and propose a comprehensive vision for the region. Fulton, Herkimer, Montgomery, Oneida, Otsego, and Schoharie counties formed an alliance to disrupt the status quo. Strengthening American manufacturing, revitalizing our cities and villages, creating global tourism destinations, modernizing infrastructure, and pursuing the advanced industries of the future.

#### PROGRESS

Empirical data, physical evidence, and socioeconomic indicators all suggest that economic health in the Mohawk Valley is trending positive. Manufacturing and exports are growing, infill development in our city and village centers is robust, visitor spending is at an alltime high, our cyber cluster is achieving critical mass, opportunities abound for an increasingly diverse family of individuals, and we've succeed in our moonshot.

More than 600 new projects - totaling over \$600 million in grants - have catalyzed \$1.8 billion in new investment across our region and created or retained almost 10,000 jobs.

Industry expansion and adaptive reuse has kept community planning boards busy these last twelve months, and resulted in an historic increase in building footprints, capital investment, and revitalization of some of the most historically blighted neighborhoods. More than 500 market rate and affordable housing units are planned or under construction in our population centers, and nearly two million square feet of vacant and blighted structures will have been repurposed, rehabilitated, or demolished since our last report.

The numbers jive, and the physical construction is undeniable. But some of the more nuanced signs of progress is best demonstrated in our communities, our neighborhoods, and our classrooms. Refugee resettlement, community development initiatives, and workforce training programs are bearing fruit.

Despite despotic attempts to curb immigration, our region continues to welcome new Americans and empower them through support networks, skills training, and connections to opportunity. Rebuilding decaying infrastructure and building new pedestrian connections from neighborhoods to schools, parks, services, and employment centers has resulted in more walkable, livable communities.

Our schools, colleges, and universities are responding to the needs of employers with ever-evolving, industry-advised curriculum that targets today's underemployed and the next generation of workers.

#### ON DECK for 2020

The MVREDC is proposing 30 new priority projects totaling more than \$20 million in ESD grant requests and more than 50 projects totaling nearly \$40 million in grant requests to programs that improve water quality, modernize infrastructure, convert waste to energy, stimulate mixed-use and affordable housing development, enhance tourism destinations, help families to overcome barriers to employment, address environmental justice inequities, and lay the foundation for new development in rural communities. And every new dollar is critical to sustaining the momentum.

ESD Priority Projects this year include massive investments in cyber capabilities and information security infrastructure, foreign direct investment in food manufacturing, mixed-use development to support a younger workforce and vibrant cities, new flexible child care options, and the continued expansion of American manufacturing. This \$22 million in ESD capital grants will stimulate more than \$156 million in new public and private investment.

Homes and Community Renewal continues to play a pivotal role in community development, public infrastructure, and small business growth. Projects proposed include modernizing water and sewer infrastructure in Cobleskill and Gloversville; with both communities also seeking Main Street Anchor projects. A cultural community center in Amsterdam is being proposed as a multi-cultural partnership between Centro Civico and the Boys & Girls Club to improve access to opportunity for families on the East Side. Additionally, new microenterprise grant programs are being submitted in Schoharie, Otsego, Montgomery, Herkimer, and Oneida counties to assist small business and entreprendurs create new products, processes, and employment opportunities in both rural and urban neighborhoods across the five counties.

Cultural, Arts-based, and Tourism projects being proposed for NYS Council on the Arts and Market NY funding range from arts-based workforce initiatives in Fulton and Schoharie counties to world-class exhibits in Utica and Cooperstown. Continued support for arts and tourism destinations will propel visitor spending in the Mohawk Valley to more than \$2 billion next year.



The New York State Canal Corporation opened a new section of the Erie Canalway Trail in the Mohawk Valley. This \$5.4 million section runs from the Fort Herkimer Church at the German Flatts Town Park on Route 5S to Erie Canal Lock E-18 in German Flatts.

Waterfront, Parks, and place-based initiatives are seeking funding from the Dept. of State, Parks, and NYS Canals, to increase access to greenspace for historically marginalized neighborhoods and stimulate new investment. Canal-front and historic preservation projects are proposed for the llion marina and Schoharie Crossing, Local Waterfront Revitalization projects include comprehensive planning for Oneonta, llion, and Amsterdam as well as a major downtown placemaking project in the Copper City.

Finally, critical infrastructure funding is being sought to address long-standing environmental injustices and physical barriers to healthy lifestyles. This year, wastewater treatment projects serving urban populations in Rome and Utica are seeking NYSERDA Net Zero and DEC Clean Water funding to build and enhance anaerobic digesters in order to convert waste to energy while providing new outlets for household and commercial organic waste - resulting in cost savings for taxpayers and operational efficiencies for business and industry.



Dave and Suzanne knew they could do some amazing things with the company. So they packed up their two small boys and moved to Cherry Valley, NY. They have a passion for the area and promoting all things local and New York State.

Once things had gotten off the ground Suzanne knew the focus had to be in really experiencing what New York has to offer. She became a board member of the Destination Marketing Corporation of Otsego County, and the Cooperstown Beverage Trail to promote local tourism and bring people to the area.

Red Shed pursued a Market NY Grant (Round 8) to do exactly that. Since receiving the grant, they have expanded their events space and calendar and has developed experiences for visitors to taste NY through craft beer, local food and NY state products.

Dave and Suzanne love that NYS is so business centric and supportive of their efforts to grow - they are proud that NY can support the opportunity to make this happen and make the brewery a possibility.

### General Progress in the Region

#### "Started from the bottom. now we're here" -Drake

We've rewritten the narrative on the Mohawk Valley. Gone are the days of job loss, quiet main streets, and community apathy. Decades of disinvestment in the Mohawk Valley culminated in the Great Recession. But from this lowest of places, we've come roaring back. The Mohawk Valley is now home to bleeding-edge technology, diverse housing, collaborative work environments, recreational adventures, and cool places. We owe this, in large part, to the Governor Cuomo's creation of the Regional Economic Development Councils.

With the rust shaken off, malaise has given way to unbound comunity pride. We see this pride on Main St. in Oneonta, which is undergoing transformation through the Downtown Revitalization Initiative. We see it at the

Mohawk Gateway Overlook, which has helped connect people and neighborhoods in Amsterdam, and serve as a beautiful community gathering and public space. We see it in the sea of Comets jerseys in the stands at the Adirondack Bank Center on any given hockey night. The MVREDC's focus on creating vibrant communities and on advancing strategic industries has paid dividends. We've seen growth in employment, wages, and output in each of these industries. From this foundation, we can look forward to continued economic growth.

In our region, manufacturing, tourism, innovation, and food systems are flourishing. Across the Mohawk Valley, manufacturers are growing and modernizing, evidenced by projects such as Trenton Technology's expansion of computer circuit board production in

Utica. Tourists are visiting and spending more, as a result of investments in tourist destinations such as Howe Caverns and the National Baseball Hall of Fame and Museum. And our scientists are working on cutting-edge innovations in areas such as heart research, drone technology, and quantum computing in world-class facilities. This progress is exemplified in the growth in regional GDP, which since 2010 has increased by over 21%. In just the past two years, regional GDP has grown by nearly 9%, amounting to \$21.43 B in 2018.

Manufacturing in the Mohawk Valley is in high gear. In 2018, this sector accounted for \$2.5B of regional output, making it one of the largest sector of the economy. Between 2015 and 2018, regional manufacturing has grown by 20%. Moreover, each of the region's five largest manufacturing sectors strongly align with MVREDC strategies: advanced manufacturing and agribusiness. Primary and fabricated metals manufacturing account for two of this region's largest manufacturing sectors, amounting to nearly \$700 million worth of output and nearly 4,000 employees. These sectors include past CFA recipients such as Homogeneous Metals (2012), OW Hubbell (2017), JBF Stainless (2017), and Deployed Resources (2017). Each of these manufacturers have undertaken substantial investments in their physical space and/or equipment in order to modernize and expand production.

Across the six counties, metals manufacturers paint a brilliant picture of the region: Keymark Corporation in Montgomery County, one of the state's leading aluminum producers, is among the largest employers of refugees in the region. In Oneida County, Sherrill Manufacturing Inc. rose from the ashes of Oneida Limited's closure, and is now the nation's only producer of flatware. The company's sales continue to rise, and as a result, the company continues to hire.

We have seen significant growth in other top manufacturing sectors as well. In 2018, machinery manufacturing accounted for nearly \$160 million in overall output and over 3,000 employees across the region. Just this year, Briggs & Stratton has moved into a completely modernized space in the Silver City Industrial Park in Sherrill, more than doubling its footprint and greatly increasing production capacity of commercial-grade outdoor power equipment. This \$22+ million project was made possible by a combination Briggs & Stratton's vision, grit and creativity by the property developer, unwavering support by local leadership, and a game-changing REDC investement of ESD grants and

tax credits. Employing more than 500 people in Oneida County, Briggs & Stratton is one of the largest machinery manufacturers in the Mohawk Valley and one of the most stunning example of brownfield revitalization in the region's history.

In 2018 the MVREDC continued its work to position the six-county region as a world leader in cyber, IT, and UAS capabilities. Since 2015, professional, scientific and technical sector has grown over 25%, in large part from growth in our cyber and IT cluster. As the Air Force Research Laboratory (AFRL) continues to grow and diversify its areas of research, the number of private firms supporting this research also grows. AFRL has long been a leader in the areas of command and control, communications, computers, and intelligence. This work enabled homegrown IT companies such as Assured Information Security and Black River Systems Co. to start and grow, and it also attracted worldwide firms such as BAE Systems and Booz Allen Hamilton. Today, this ecosystem of private cyber and IT employers, centered at the Griffiss Business & Technology Park, contributes roughly \$300 million to the region's economy, and complements the \$400+ million economic impact of AFRL.


Cybersecurity is a field that is constantly evolving, trying to keep up with the ever-present cyber threats that affect our military, governments, businesses, and citizens. The Mohawk Valley's cyber cluster is on the front lines assessing, preventing, and responding to these threats. Additionally, with AFRL research expanding into areas such as quantum computing, artificial intelligence, and autonomous vehicles, we have already seen new partnerships and businesses in our region to support these investments. To facilitate this, we see investments such as the Open Innovation Campus at Griffiss Business and Technology Park. This \$12 million investment was announced in August and is a partnership between AFRL, Oneida County, SUNY Polytechnic Institute, and the Griffiss Institute. The Open Innovation Campus will enable easier collaboration among stakeholders to solve problems in the areas of computer hardware and software, data protection, cybersecurity and artificial intelligence.

Growth in manufacturing and agribusiness is substantially fueled by increasing global demand for homegrown products and services. Since 2010, regional exports have increased 34%, amounting to \$2.46 billion in 2017. From food to fabricated metal, the Mohawk Valley stacks up on the world stage. The region's agribusiness sector is not just filling pantries and refrigerators across the Mohawk Valley. In 2017, \$210 million worth of food products were exported around the world. One example of this is Mercer's Dairy in Boonville. This producer of ten varieties of wine ice cream sends product to Russia, Estonia, Nicaragua, and beyond. The Mohawk Valley is also a significant exporter of computers and electronic products, with nearly \$95 million worth of product going abroad. This number stands to grow as investments such as at Danfoss Silicon Power enhance regional production capacity and brings the Mohawk Valley into the center of the worldwide computer and nanotechnology market. Metal products accounted for over 38% of total exports in 2017. A slice of those exports come SAES Smart Materials, a manufacturer of shape-memory alloys in Oneida County. This advanced manufacturer of super-elastic metals sells component parts to manufacturers of medical devices, automobiles, and flexible packaging around the world.

The growth we see in the Mohawk Valley economy translates to stronger businesses, stronger communities, and stronger households. As the economy has grown stronger, this has created a very tight labor market. As this labor market has strained, it has put pressure on wages. As a result, we have seen strong growth in both total wages and average wages in the Mohawk Valley. From 2010-18, total wages in the Mohawk Valley grew from \$6.87 billion to nearly \$8.13 billion, amounting to over 18% growth. Most of this overall wage growth was driven by the private sector, which saw a 23% increase during that time, compared to nearly 7% in the public sector. Average wages in the region grew by over 16% from 2010-18 for an average of \$42,498 today. In the private sector, wages grew by more than 20% during that period, for a regional average of \$40,452. This rate slightly outpaced the New York State rate of 19% over the same period. Meanwhile, the average public wage in the Mohawk Valley grew by 15% from 2010-18, to \$49,500.

Wages in each of the Mohawk Valley's strategic industries experienced significant growth as well. Across the region's agriculture and agribusiness sector, over 5,700 workers have seen average wages grow by nearly 15%, for an average of \$43,507. The MVREDC has supported agribusiness investments that have contributed to this industry growth and wage growth. In Fulton County, Fage USA's 2011 CFA grant was part of a \$100 million expansion that doubled production capacity and added 100 jobs. In Schoharie County, a 2012 Agricultural Assistance Program grant was used to update technology and equipment for local farmers. This much-needed direct assistance to farmers allowed for continued


#### **Global Exports % Change Since 2010**

innovation on the farm and the diversification of traditional farm stands into agritourism destinations.

Employees within the Mohawk Valley's tourism sector have seen a nearly 60% increase in average wages from 2010, to nearly \$30,000 in 2018. With visitor spending topping \$2 billion in 2018, the region's tourism employers have found serious need to bring on additional workers, such that the Mohawk Valley is now home to almost 5,000 tourism industry employees. There is an understanding across the region that as the tourism industry continues to expand and diversify, it needs to hire and retain a dedicated workforce. Employers such as the Oneida Indian Nation, Baseball Hall of Fame and Museum, and Howe Caverns acknowledge that keeping the region's tourism economy justifies these rapidly increasing wages.

As demonstrated in the Mohawk Valley's export statistics and in the region's GDP growth, the advanced manufacturing cluster continues to grow. In 2018, advanced manufacturing represented over \$670 million of the regional economy, or about a guarter of all Mohawk Valley manufacturing. From 2017-18, more than 100 jobs have been added among our advanced manufacturers: and the average wage for those workers now sits at \$54,394. This wage is 28% higher than the Mohawk Valley's regional average wage, and amounts to 23% growth since 2010.

The Mohawk Valley's workforce is well-suited for the growth occurring in the advanced manufacturing sector. Many of the jobs being created at our advanced manufacturers require some mixture of an associates degree, special certification, and on-the-job training. In the Mohawk Valley, over 31% of the working age population possesses an associates degree or some college education, which would be inclusive of certificate programs offered through local community colleges. The 12.5% of Mohawk Valley adults that have an associates degree is higher than rates seen in across all of Upstate NY, all of New York State, or the United States. This demonstrates the availability of "middle skills" so crucial to many regional manufacturers.


Through sound investments in our region's workforce, strategic industries, and main streets, we are showing businesses and people across the world why the Mohawk Valley is a place worth calling home.






Population Ages 20 - 34 Percent Change Since 2011

In January 2000, when Compassion Coalition was launched, West Utica was a food desert. Bargain Grocery (CFA Round 5 & 7) has allowed food accessibility and equality in a food desert, while allowing the proceeds of the store to be re-invested into our local communities.

In December of 2018, Bargain Grocery grew from 1,200 sq ft to over 13,000 sq ft and their customer base has grown by 45%. Proceeds from the store have allowed Compassion Coalition to give more than \$20 million in donated goods each year, and serve more than 350,000 individuals yearly. Their staffing numbers went from six full-time employees to 12 and 14 part-time employees to 34. An increase of 26 newly created jobs. Eleven of these employees are foreign born, while several have prior criminal records. Despite these barriers, Bargain Grocery offers people a second chance at meaningful employment and healthy lifestyles.

# Status of Past **Priority Projects**

CYBERSECURITY, UAS, STEM INTENSIVE INDUSTRIES, AGRIBUSINESS/FOOD SYSTEMS, AND TOURISM.

PROJECT ALIGNMENT WITH KEY REGIONAL STRATEGIES HAS CREATED NEW OPPORTUNITIES FOR RESIDENTS IN FULTON, HERKIMER, MONTGOMERY, OTSEGO, **ONEIDA**, and SCHOHARIE COUNTIES.

In the Mohawk Valley, agriculture is serious business. Across our six counties, it amounts to a \$211 million dollar industry. There are 675 dairy farms across the region supporting a nearly \$200M dairy manufacturing industry. That means that from the cow on a Herkimer County farm, to the Fage yogurt or Hood cottage cheese in your refrigerator, the region's dairy industry is a major contributor to New York's perennial top three ranking among dairy producing states in the Union.

SUNY Cobleskill is on the front lines of ensuring this industry remains strong in the Mohawk Valley. Set to open this year, the college's new Dairy Processing Center (CFA Open Round) is undergoing final equipment installation and completing regulatory processes. This facility is funded in part by a \$1 million grant from ESD. The Center will serve as a hub for dairy processing and education in the Mohawk Valley. This new facility will support academic programs at SUNY Cobleskill such as its Dairy Production & Management and Food Systems & Technology degrees. Beyond the College, a variety of workshops and certificate courses related to production and processing technology, sanitation, and food safety will be offered.

The Mohawk Valley Farm & Food Business Incubator (FFBI) (CFA Round 5 & 7) will leverage the Center's resources to develop new products and entrepreneurs. ncubator residents will have access to equipment for processing their own farm-branded products or for participating in regional brand initiatives. One such initiative is the campus's new retail facility –Carriage House Café & General Store — which is now selling campus-produced milk and serving as a hub for product development research, and a home for FFBI clients.

This relationship with the Dairy Processing Center will build on the success experienced at the FFBI over the past three years since being funded through ESD in 2015. During that time, FFBI has hosted nearly 60 workshops with over 300 workshop attendees from the farm/food business community, and is actively working with 30+ clients on business plan development, marketing assistance, access to credit, and access to production/processing spaces.

OPPORTUNITY FOR ALL. In May 2018, the Central Association for the Blind and Visually Impaired (CABVI) broke ground on its new rehabilitation and wellness center in Utica. This project, funded through a \$1.7 million grant from ESD in 2016 will create an \$8.5 million 23,000 square-foot building to house vision



t in Sharon Springs draws tens of thousands of peo ach vear in September. Sharon Springs is a unique example s, tourism, placemaking, entrepreneurship, and

rehabilitation services, as well as a research laboratory, fitness center, and therapy pool. CABVI's new rehabilitation center is nearing completion, and is slated to open this year.

This endeavor exemplifies the harmony betwen our Opportunity Agenda and Environmental Justice strategies. This project is creating 20 jobs, many of which will be filled by individuals who are blind or visually impaired. And the services provided by CABVI are unique to other such organizations across the country, and as a result client demand has grown significantly: over the next ten years, CABVI expects to grow its number of clients by nearly 70%, for a total of more than 2,700 individuals served across the Mohawk Valley, Upstate New York and the entire Northeast.

ENTREPRENEURSHIP. The success of the Commercialization Academy program at the Griffiss Institute (CFA Round 3 & 6) gave rise to the Mohawk Valley's IDEA NY business accelerator program, announced by Governor Cuomo in 2018. By assisting entrepreneurs with commercializing patents from the Air Force Research Lab (AFRL) in Rome, IDEA NY has helped create more than 40 start-up companies, while providing them more than \$550,000 in seed funding. To accelerate this combination of creative people, ideas, and capital, the Mohawk Valley Regional Economic Development Council awarded the Griffiss Institute a \$2 million Upstate Revitalization Initiative grant to launch the IDEA NY business accelerator program.



The Mohawk Valley Resource Center for Refugees (MVRCR/The Center) is in final stages of completing the Welcome & Opportunity Center funded through the NYS Regional Economic Development ESD Funding (Rounds 3 & 7). The project has allowed MVRCR to assist people like Enock.

Enock Makoma is a former Congolese refugee. He was born and raised in a refugee camp in Rwanda and was resettled in Baltimore. After 8 months living in Baltimore, Enock and his family chose to relocate to Utica for its smaller size and lower cost of living.

Upon arrival in Utica, a friend recommended that Enock and his family visit The Center for assistance. Although Enock and his family were not resettled initially in Utica, they were eligible for assistance from The Center as secondary migrants. Enock's parents were able to attend ESOL (English for Speakers of Other Languages) classes at The Center, and his father secured a job through the Employment and Workforce Development program.

Education is something very important to Enock. He was disappointed to find out that he could not attend high school in Utica because of his age.

The educational classes offered at The Center helped Enock continue his learning initially, and his teachers took note of his success and referred him to BOCES to study for his GED. Enock received his GED and studied briefly at Mohawk Valley Community College before transferring to Herkimer College.

Currently, Enock is a general studies student at Herkimer College and is shaping his coursework toward civil engineering. After Enock graduates from Herkimer College, he wants to attend SUNY Polytechnic Institute to further his civil engineering studies. Recently, Enock became a United States citizen. Once Enock finishes his initial civil engineering education, he wants to get a job in his field, start a family, and eventually go back to school for his master's degree.

Enock is an avid volunteer at The Center's resettlement department and works as an interpreter for Compass Interpreters, The Center's interpretation department. Enock urges other refugees never to give up and to pursue the educational opportunities available in the United States.



Governor Andrew M. Cuomo announced this past September a major public-private partnership between the State of New York and Cree, Inc., the global leader in silicon carbide technology, to invest approximately \$1 billion over six years to construct and equip a new, state-of-the-art, highly-automated world's-first, 200mm silicon carbide wafer fabrication facility. This investment also includes a \$30 million research and development commitment by Cree, with plans to create over 600 full-time highly-skilled technician and engineering positions at the Marcy Nanocenter on the SUNY Polytechnic Institute campus near Utica.

# Implementation Agenda

### Strategies and Actions **Related to State Priorities**

tate priorities evolve, but the guiding principle behind them remain unchanged: work each day to guarantee opportunity and prosperity for the many, not just the few. Over the years, we continue to accomplish this by addressing barriers to employment, arming families with the tools to succeed, rebuilding neighborhoods and infrastructure, and being stewards of New York's natural resources.

This year, we dive deep into some of the most basic, fundamental threats to opportunity and align our priorities with projects and actions to improve access to quality childcare, to build a diverse and skilled workforce, to continue to create great places to live and work, and to begin to reverse environmental justice issues in historically underserved neighborhoods.

#### **REMOVING BARRIERS TO OPPORTUNITY**

Eight years of public engagement, regional planning, business and stakeholder outreach, and project implementation have revealed fundamental barriers to opportunity. Among these are lack of transportation, poor pedestrian infrastructure, language and cultural differences, local skills gaps, and access to quality and enriching childcare.

#### Access to Childcare

This year, the MVREDC is working with Cornell Cooperative Extension to develop a regionally-specific strategy to tackle this issue. The primary goals are to:

- Increase the number and distribution of quality, affordable caregivers in the region – including proximity to major population and employment centers
- Improve access to childcare through alternative transportation, pedestrian connections to under-served neighborhoods, employer participation, and elimination of cultural barriers.
- Advocate for and incentivize higher pay and benefits for child care workers.

Last year the MVREDC identified Access to Childcare as a major hole in our ecosystem, and supported the Empire State Poverty Reduction Initiative Project (ESPRI), a 24 hr. Daycare through Round 8 of the CFA. As a result, focus has been put on Access to Childcare throughout NYS. The Mohawk Valley REDC Access to Childcare Workgroup views The ESPRI childcare project as a model for the region and state. So many of the regional employers require shiftwork and having 24/7 access to childcare is not a luxury; it is a priority. The Extended Childcare invests in our children and their parent's ability to complete their education, attain better paying jobs and work all different workshifts. It invests in a longtime centralized downtown building and it expands upon the efforts of expert childcare providers. These economic investments not only benefit families by eliminating barriers to employment but also community sustainability and revitalization. This is the first project of its kind in NYS!

The New York State Council on Children and Families (CCF) New York State Birth Through Five Project (NYSB5) awarded grants of up to \$15,000 to Child Care Resource and Referral Agencies that partner with their Regional Economic Development Councils (REDC) to identify challenges and collaboratively assess their region's child care needs. The initiative recognizes child care as an economic development issue that child care providers and the business community must work together to address. Cornell Cooperative Extension in partnership with The Mohawk Valley REDC's Access to Childcare Workgroup, was awarded a \$15,000 grant to assess our region's child care needs. Survey research, community input, and resulting data will be used to create a child care strategy for the Mohawk Valley Region. Additionally the Mohawk Valley REDC has prioritized three projects in 2019 that will assist in alleviating this barrier: Whispering Pines Preschool, Herkimer County Foltsbrook Center, and Eastern Gardens Head Start.

#### Workforce

Regardless of industry, the most recurring concern from Mohawk Valley employers is the need to find reliable workers. In the second guarter of 2019 alone, there were over 14,800 job openings in the region. Many of the jobs advertised across the Mohawk Valley go unfilled; the labor market is tight, and the skills needed by employers often do not match those possessed by potential applicants.

Workforce is quickly becoming the limiting factor to growth – no matter the industry – which is why we find it absolutely necessary for the MVREDC to stay on top of this issue. That is why several of our priority projects are based on training a 21st Century workforce while cultivating innovators and entrepreneurs in our population centers. The MV Resource Center for Refugees continues to invest in diversity – and we are 100% behind them. The fresh perspective, limitless talent, and positive attitudes that our immigrant and new American cultures bring are precisely the solution to the national workforce shortage. This new center in downtown Utica will focus on soft-skills for unemployed and underemployed individuals regardless of race. color, or origin.

The Masonic Medical Research Institute is winning hearts and minds – quite literally. It is no wonder that one of our favorite priority projects this year is the next phase of development at MMRI. With the continued investment and expansion, now in its third phase, MMRI is attracting world-class doctors and researchers to the Mohawk Valley. In addition to the groundbreaking research, the MMRI is prolific in its ability to develop and commercialize new technologies that continue to touch the lives of millions of cardiac patients around the world. With their ability to attract the best of the best, MMRI is creating a nucleus from which to building a pipeline of skilled and diverse bioscience professionals. This is important for so many reasons – especially since the life science talent pipeline will ultimately determine the future and quality of healthcare at the new MVHS campus in downtown Utica.

In Downtown Gloversville, the FCCRG is implementing the next phase of its urban revitalization strategy by creating 10,000 square feet of incubator space for small business and entrepreneurs. Part of the proposed DRI strategic investment area, the incubator will contribute to a more vibrant downtown and encourage a new class of innovators and risk takers as

Gloversville rebuilds. Working Kitchen rounds out the downtown-based craft industry with an opportunity for budding entrepreneurs, chefs, brewers, cheesemongers, and organic farmers to hone their skills while contributing to critical mass in the DRI investment area.

#### **Environmental Justice & Smart Growth**

Owing to high poverty rates, an increasingly diverse demographic, and a plethora of industrial brownfield properties, our regional strategies and priorities in the past have targeted environmental inequities – primarily from the perspective of infrastructure, infill, and community facilities. Governor Cuomo's initiative prompts us to look at ALL projects with fresh eyes, and to honestly consider each project's impacts on environmental guality and vulnerable populations. The key is to first recognize that Environmental Justice and Smart Growth (EJ-SG) cuts across all things. This rationale guiding our new EJ-SG strategy not only seeks to expand the tent, but to also provide the regional council a methodology to evaluate projects.

Among the most comprehensive and geographically impactful projects is the City of Rome's proposed Net-Zero biodigester. With Chobani as the driving economic force, the City will expand their anaerobic digestion capabilities to handle high-strength dairy waste and organic waste produced by restaurants and households. As a result, the project will reduce vehicle miles traveled by dairy haulers, produce 100% renewable energy from organic waste, reduce operational costs to the taxpayer, improve water quality of effluent flowing into the Canal, and reduce the amount of waste entering the regional landfill.

Community engagement and involvement has always been encouraged as part of the project development process, requiring this input will be a critical part of the EJ-SG agenda. The best time to engage is from the very beginning, and this is the genius of the Brownfield Opportunity Area (BOA), Downtown Revitalization Initiative (DRI), and Local Waterfront Revitalization Program (LWRP). This year, we propose two new BOA studies for the City of Gloversville and the Village of Dolgeville – both communities with poverty rates exceeding 20% yet flush with natural resources and a yearning for change. The BOA will begin at the grass roots, and afford families, businesses, and elected officials the chance to outline and implement a sustainable and inclusive vision for their communities.



The Mohawk Valley Gateway Overlook (MVGO) will continue to develop new exhibits and activities as part of an ongoing plan to create a new urban corridor that spans and connects both sides of the river. The American Planning Association has designated MVGO pedestrian bridge in Amsterdam as one of six "Great Public Spaces" added to its annual Great Places in America list.

In parallel to the REDC, the Community Foundation of Herkimer & Oneida Counties is committed to a multi-million-dollar initiative aimed at reducing childhood lead poisoning and supporting access to healthy housing in Herkimer and Oneida counties for the next decade. The Foundation will lead and coordinate "Lead-Free MV" with multiple community partners, including the Oneida County Health Department, Herkimer County Public Health and Herkimer County HealthNet among many others. Lead-Free MV, as a 'Collective Impact Initiative,' provides a framework to tackle this deeply entrenched and complex social problem, through an innovative and structured approach empowering government, business, philanthropy, nonprofit organizations and citizens to collaborate and achieve significant, lasting social change. Coalition members represent public health, local government, legal, insurance, healthcare, education, child care, construction and support services constituencies.

Future projects will certainly require additional forethought, introspection, and a hard look: Will this result in exurban sprawl and place a burden on future generations? Will the siting of this project disproportionately impact minority or low-income families? What measures does the project take to improve the neighborhood and environment? Has the local government engaged the most vulnerable populations? Fundamentally, would you support this project in your own backyard?

#### **PLACEMAKING & DOWNTOWN** REVITALIZATION

A fundamental right of all Americans - all humans - is the pursuit of happiness. In its most elemental form, this is the inspiration behind the Governor's Placemaking strategy - as embodied in the Downtown Revitalization Intitiative (DRI). New York State has invested more than \$2 billion in the Mohawk Valley since 2011 to help us build a sustainable future. In return, we have committed to investing in places that empower people.

Each of the DRI Strategic Investment Areas share this common thread. We focus on downtowns because two out of every three people resides in Cities and Villages. East Main Street in downtown Oneonta. West Dominick Street in Rome, and Bridge Street in Amsterdam's South Side are all places where people meet, ideas exchange, and entrepreneurs boldly endeavor. This intercourse of thoughts, emotions, dreams, vibes, and memories is largely determined by the quality of place; and this is reflected in our careful placement of capital.

In Amsterdam, the Mohawk Gateway Overlook has connected the north and south banks of the Mohawk River, and by doing so, has connected two long-estranged neighborhoods; like an axon connecting two synapses. The proof is in the new small businesses, tourists, festivals, weddings, and multi-cultural music. The DRI seeks to capitalize on this new energy. Adding to the critical mass of people and activity downtown, Amsterdam is proposing the construction of a community center on E. Main Street to serve as a communal hub for arts, education, and healthy lifestyles.

In the Rome DRI, the simple demolition of a massive, decrepit parking garage has eliminated decades of blight. But more importantly - and frankly, unexpectedly - it has let in the sunlight. Surrounding windows of apartments and offices are illuminated, and where there was once concrete and steel, Rome's elderly, disabled, and office workers are surrounded by trees, sunshine, and the sounds of the downtown market.

In the City of Sherrill, Sliver City Lofts will rehabilitate 100+ year old offices into a mixed-use development on the campus of Silver City Industrial Park. The apartments and lifestyle commercial space will retain the historic character and industrial flavor; designed to support the growing workforce at Briggs and Stratton, Upstate Stone, and Sherrill Manufacturing.

And in Oneonta, the Downtown Improvement Fund continues to brighten facades and awnings on Main and Deetz streets, while creating new, high-quality loft apartments above the storefronts - a winning formula and why Oneonta's Main Street is one of the most vibrant in the Valley.

Building on this momentum, the Ford Block Revival in downtown Oneonta will restore the historic structures and create 25 new loft apartments above modern commercial and retail space. A few blocks away, a working kitchen is being proposed on Main Street to accelerate entrepreneurship and community engagement in craft food, beverage, and arts.

This year, we stay the course with smart growth through adaptive reuse in our urban centers. As we continue to support projects that add to the ecosystem for business and industry to flourish, we are mindful that our true purpose is to create an safe and healthy environment in which individuals, families, and neighborhoods can grow and thrive.

#### SPARKING TRANSFORMATION

Two Years ago, in 2017 Howard Zemsky was our Keynote Speaker at our MVREDC kick-off event. His message was to "strike while the iron was hot." To utilize the Upstate Revitalization Initiative (URI) funding toward transformational projects. The Mohawk Valley REDC, elected officials, and regional stakeholders heard Howard and have done just that. Two years later in the same location at our kick-off, the MVREDC reported that we had awarded \$34.5 Million of our \$50 Million dollars on the following transformational projects:

\$1.5 million URI Award to The Mohawk Valley Resource Center for Refugees (The Center) to establish a One World Utica Welcome & Opportunity Center intended to foster and enhance the welcoming community climate in the City of Utica.

\$2 million URI Award for IDEA NY The Innovation & Development Entrepreneurial Accelerator (IDEA) NY business accelerator competition and 12-month pro-

gram will build entrepreneurship and grow the region's innovation economy.

\$3 million URI Award for Historic Doubleday Field, which opened in September 1920 with wooden grandstands and has since grown to a nearly 10,000-seat stadium, will get be modernized and preserved with the help of a July URI grant.

\$6 million URI for Utica's Harbor Point Bulkhead Project, the last remaining infrastructure improvement needed to entice private sector development.

\$22 million in URI grant funding to the Upper Mohawk Valley Memorial Auditorium Authority for the construction of the Nexus Center, a world-class, tournament-based sports complex in downtown Utica. The Nexus Center will be a 169,440-square-foot facility to be utilized primarily for ice hockey, box lacrosse, soccer and other field sports, and will draw competitive youth teams from across the U.S and Canada.

\$500,000 Enchanted Forest Water Safari Expansion Project to help expand and enhance the globally recognized theme park as the resort adds three new water slides and replacing two older slides. Enchanted Forest attracts more than 200,000 visitors annually from all over the United States, Canada, and other countries.

In his parting message, Howard Zemsky urged us to be ambassadors for the URI, to continually seek unique, transformative projects across the region; and that when we do, New York will be there to support us.

# Implementation of Key Regional Priorities

he spectrum of priority and regionally-significant projects for 2019 are a clear reflection of the MVREDC regional priorities: Cyber and Information Security, STEM-Intensive Advanced Industries, International Tourism Destinations, Agribusiness & Food Systems, and Modernization of American Manufacturing. Central to each of these is building vibrant communities and creating an environment in which all of our families, small businesses, and entrepreneurs can grow and thrive. It is a rare occasion that a priority project achieves only one objective. Rather, the projects we propose for funding fulfill and strengthen multiple strategies.

#### A MATURING ECOSYSTEM

As a predominantly rural region, composed of six counties with no central metro center nor a common media market, we have had to work a little harder to build lasting relationships and adopt a common vision. At the onset in 2011, the idea of collaboration was proffered to the six counties.

Over the course of eight years, our ecosystem has developed and matured. All of our organizations are truly talking, sharing best practices, partnering in planning, and supporting one another's initiatives. In this short time, we have witnessed the evolution of EDOs and even the birth of new species.

In a disruptive move, the Otsego IDA restructured into Otsego Now; leading the DRI movement and strengthening partnerships with academia and craft producers. Otsego Now is instrumental in the prolific expansion of craft brewing, distilling, and agritourist; amplifying the allure of Cooperstown's international brand.

The re-energized Herkimer County IDA has, in the span of less than three years, fully developed a nearly 200acre business park, accelerated development of an additional 170-acres, and is pro-actively performing a county-wide environmental site investigation initiative.

Fulton County Center for Regional Growth's (FCCRG) transformation of Tryon Tech Park and downtown Gloversville is just the beginning. Tryon was among the first medical cannabis research and production facilities in New York; and FCCRG is investing heavily in its new downtown headquarters to establish a downtown center for innovation and incubation.

Montgomery Business Development Center (MBDC) has asserted dominance in the logistics sector while becoming a powerful force for downtown revitalization in Amsterdam. MBDC has led the herculean effort to redevelop the infamous former Beech Nut complex - visible from the NYS Thruway to hundreds of thousands of residents and visitors every day.

In Oneida County, Mohawk Valley EDGE has continued to support strategic industry growth and downtown development in Utica, Rome, and villages across the region's most populous county. EDGE has ground out their niche and consistently, methodically developed the nation's most infrastructure-rich, pad-ready site for semiconductor fabrication. When the opportunity presented itself, EDGE was prepared to strike resulting in the recent announcement of the planned construction of the world's largest silicon carbide power electronics research and fabrication facility in Oneida County.

In Schoharie County, we have an entirely new animal. In 2018, SUNY Cobleskill, community & business leaders, and stakeholders completed Shaping the Way Forward: An Economic Development Strategy for Schoharie County – a study unanimously supported, funded, and inspired by the MVREDC. Among the recommendations are to fertilize the already vibrant agribusiness cluster, to support business and tourism growth, and attract new talent and industry.

Regional Council members from the six county region joined to effort to inform the process. First among the actions was to form an agile EDO to execute the plan. In early 2019, the Schoharie Economic Enterprise Corporation (SEEC) was founded and just this summer, has named its first Executive Director. This is an historic effort for the county and a testament to the power of collaboration.

#### PRIORITY PROJECTS ADVANCING REGIONAL STRATEGIES FOR 2019-2020

Cyber is more important today than at any point in our history. The most active front in global conflict is in cyberspace, and the information security technology currently being developed by the Air Force Research Laboratory Information Directorate and its constellation of private contractors will determine the outcome. Project Charger is the most aggressive, highestimpact Cyber-centric expansion proposed since the designation as the regional Cluster. Nearly doubling their footprint and expanding their already "devastating capability," the Park's premier information security company will bring more than 40+ of the nation's top computer science and software developers to the Mohawk Valley to engineer solutions to the nation's most complex national security problems, while working with the AFRL and Griffiss Institute to develop secure communication platforms for Unmanned Systems.

In today's global marketplace, manufacturers are compelled to modernize and integrate new machinery and computer controlled systems. The Mohawk Valley's prowess in metals and fabrication is abundantly evident in this year's priority project list, and we intend to support their efforts to modernize, innovate, and continue to grow regional exports. Collins Aerospace will invest more than \$27 million to modernize their facility and integrate state of the art machinery and processes into their aerospace power transmission systems division in Rome. In Little Falls, Feldmeier Equipment will construct an additional 89,000 square feet to incorporate automation and explore new markets in food and beverage manufacturing. Metal Solutions in Utica will purchase three key pieces of equipment, and projects 25% growth in sales as a result.

Also modernizing and exploiting new markets, our region's agribusiness sector is seeking state investment in new facilities, equipment, and processes. Sovena USA is planning its first major expansion – with foreign direct investment – in order to meet market demand for olive oil and a growing variety of edible oils across North America.

In Canajoharie, agribusiness entrepreneurs will spend nearly \$7 million to establish an industrial hemp farm, indoor growing operation, and buildout of CBD oil research and processing space in the former Beech Nut facility in the heart of the Village – representing the first private investment to follow the largest RESTORE NY project in the region in program history. In Oneonta Business Park, Otsego Now will help to establish a USDA certified Halal and Kosher meat processing facility to provide a local market to protein farmers and exporting to New York City and beyond. Just down the road, the City of Oneonta and Hartwick College are partnering downtown to create a Grain Innovation laboratory to accelerate local capacity to test and process grains for craft food and beverage manufacturing; including a space brewing startups.

Our Vibrant Communities strategy is all about people. Downtown only works when it becomes a lifestyle. Our priority project list includes six mixed-use projects that all follow the same guiding principles: historic preservation, adaptive reuse, elimination of blight, utilization of existing infrastructure, creating affordable spaces for entrepreneurs and small business, and bringing people together in a healthy, walkable, safe environment. Hotel Street in Baggs Square, Sliver City Lofts in Sherrill, Stone Mill in Little Falls, Parrot House in Schoharie, Main Street in Jefferson, and the Ford Block in Oneonta are integral to a well-balanced strategy to attract the next generation of Mohawk Valley residents and workforce.

There is a renewed interest in industrial hemp production and processing throughout the country, and with our strong grower community and innovative researchers, New York is in a great position to lead," **Governor Andrew Cuomo** said. "By providing an alternative crop for our farmers, industrial hemp has the potential to change the landscape of our agricultural economy..."

Arouca Farms of Canajoharie (Round 9 Priority Project) is an hemp cultivation farm in Canajoharie, they will be purchasing and renovating the former Beech-Nut facility, off of Exit 29 of the Thruway. The former Beech-Nut facility (RESTORE Round 5) has been in a Brownfield remediation program for the past several years and is undergoing demolition and asbestos abatement. Arouca will be renovating a portion of the facility to create an indoor hemp cultivation, processing, and packaging facility. The company will invest in high-end processing equipment, scaled to be able to toll process 500,000 acres a year. Arouca Holdings Inc. also plans to create their own craft CBD brand for health and wellness.



He is now looking to start a new business next door, and is in the process of starting his own barber school upstairs from his shop on Main Street. He won the Placemaking Award at the 2019 Placemaking Dinner, sponsored by Fulton County Center for Regional Growth. His motto is "when you are positive inside you can grow and avoid any dark times that may come your way." Mike is raising a beautiful family in Gloversville, and has succeeded in making his mother proud.

FCCRG is proposing a downtown Business Incubator (CFA #t93426) to empower people like Mike to overcome their barriers to employment, recieve the financial and technical assistance they need to succed, and make their mothers proud.

#### **PROJECT CHARGER**

**CFA Number:** 90332 Project Applicant: Griffiss Local Dev. Corp. Project Location: Oneida County Amount of award requested: \$2,700,000

**Description:** GLDC through a wholly owned subsidiary (Cardinal Griffiss Realty LLC) will construct a new, 38,000 SF addition for the current tenant's US Headquarters at Griffiss Business & Technology Park - Rome, NY. The company's decision to double their footprint in New York State will result in the addition of more than 35 new STEM jobs, create new infrastructure for innovation, and enable the company to secure additional national defense contracts. The total project cost is est. \$14.6 m.

Link to Goal or Strategy Being Implemented: From the inception of the REDC model, the MVREDC has been laser-focused on growing a STEM-based economy and workforce. Project Charger would represent the largest investment to date in the Mohawk Valley region's CYBER cluster; resulting in the creation of more than 35 new high-wage jobs, and modern offices, R&D space, and infrastructure for innovation and collaboration within the cyber community.

#### SOVENA BUILDING EXPANSION

Amount of award requested: \$950,000

**Description:** The Sovena expansion project involves additions to the current plant located at 1 Olive Grove St in Rome, including construction new warehouse space, oil tank farm space, and a paved shipping/ receiving area.

#### Link to Goal or Strategy Being Implemented:

Advanced Manufacturing and Agribusiness are the Mohawk Valley REDC strategies that this building expansion and food manufacturing project will help implement. As a result of this project, Sovena USA who's olive oil was voted best in the world in April 2019, will be able to increase production and employment in its Rome facility.

#### FELDMEIER RIVERSIDE EXPANSION

**CFA Number:** 94713 Project Applicant: Feldmeier Equipment, In. Project Location: Herkimer County Amount of award requested: \$2,500,000

**Description:** Feldmeier has outgrown its existing Little Falls facility located at 245 Riverside Industrial Park in Little Falls, NY. The company's local operations require additional manufacturing floor space & equipment. The \$16.6 million project consists of an addition and purchase of various other manufacturing equipment.

#### Link to Goal or Strategy Being Implemented:

Advanced Manufacturing and Agribusiness are key strategies that this project will help implement. Feldmeier supplies many agricultural markets vessels to store and process the agricultural products they produce and sell.





### **Participation: Work Groups**

#### ACCESS TO CHILDCARE

Responding to Governor Cuomo's call to action, the MVREDC formed a workgroup to consider the child care needs of the region as they relate to quality, access, and affordability.

Regional Stakeholders were eager to come together to address this near-crisis-level issue; as much of the region can be considered a "child care desert." Naturally, our primary goal was to support the industry in an effort to increase the number and distribution of guality, affordable caregivers. In addition to caregiver shortages, we have identified child care worker pay as critical strategy for stability and sustainability of the regional child care network.

Our Mohawk Valley Child Care Resource Referral Agency, Cornell Cooperative Extension, in partnership with The MVREDC's Access to Childcare Workgroup, has issued a survey to collect current local data to determine the need for child care to support working families. In addition, a separate survey will be given to childcare facilities throughout the Mohawk Valley to determine what their greatest challenges are in sustaining their services. The data will be used to create an access to childcare action plan for the Mohawk Valley Region.

#### ECONOMIC AND ENVIRONMENTAL JUSTICE

The MV Environmental Justice & Smart Growth working group was formed to ensure the integration of Governor Cuomo's Environmental Justice agenda into the MVREDC implementation strategy. In prior years,

the MVREDC had work groups that focused on Smart Growth, Sustainability, Vibrant Communities, and Might Waters. Our work group has refocused these closely-aligned priorities in the greater context of ensuring that the environment and human health are protected fairly for all people regardless of their status.

New REDC investment in city and village centers since 2011 has resulted in waterfront and canal redevelopment, brownfield remediation, new public greenspaces, green infrastructure, and adaptive reuse of vacant and blighted structures. Community planning and stakeholder engagement is central to these efforts – as is exemplified by the Downtown Revitalization Initiative, Local Waterfront Revitalization Program, and Brownfield Opportunity Area programs. In addition to community planning and downtown revitalization, the group will also prioritize projects that incorporate alternative energy, alternative transportation, waste management, and the protection of our natural resources.

The work group will bring these issues to the forefront and set out to reverse a century of inequitable planning and policy decisions that have had disproportionately adverse health or environmental effects on minority and low-income populations. In addition to project development that is in line with the above priorities, this group with be tasked with developing an Environmental Justice Agenda for the Mohawk Valley Regional Economic Development Council. The goal of this will be to make sure the investments endorsed by the Council do not negatively impact marginalized communities.

#### WORKFORCE COMMITTEE

The MVREDC's Workforce Committee has hit the ground running this year in response to the Workforce Development Initiative. Formed of individuals representing local business, educators, and workforce and economic development, this committee seeks to match potential State resources that enable the expansion of educational and training opportunities, and to expand pathways for career success. Committee members have their fingers on the pulse of the Mohawk Valley's workforce needs, either through their position within industry, or their regular interactions with local employers and the labor force.

The Committee meets regularly to discuss regional priorities and evaluate projects submitted through the WDI application. So far, the committee has recommended that several WDI applications be advanced for State consideration, which would expand training programs in industries such as advanced manufacturing, cybersecurity, and tourism. # Public Outreach and Engagement

### "Because none of us is as smart as all of us." -Kenneth Blanchard, Upstate NY Author

As the economic recovery continues and companies race to meet new market demand, planning boards, Industrial Development Agencies, and local legislative bodies have been busy this year. As the REDC-supported projects queue up and roll out, the importance of public outreach becomes paramount. From our point of view, project success is measured only in part by new construction, meeting employment goals, or the purchase of new equipment. We are more concerned with the lasting impacts on communities: financial impact on households, environmental impacts on local neighborhoods, access families have to these new op-

portunities. Public engagement before, during, and after these projects are the only sure way to plan for and ensure that we are being stewards of NY tax dollars.

During the past year, Mohawk Valley projects have been featured in everything from neighborhood meetings of half a dozen residents all the way to statewide summits with more than 300 participants. In each case, we've listened, learned, and adapted. In most cases, our projects were made stronger and more inclusive. In some cases, we've learned just how much harder we need to work to impact struggling families and neighborhoods. Here is how some of our public outreach - from hyper-local to statewide - have brought new projects to the fore, made old projects stronger, and expanded the tent.

• The MVREDC hosted meetings, events, and workshops in Utica, Herkimer, Cooperstown, Oneonta, Cobleskill, and Gloversville to ensure that businesses, entrepreneurs, non-profits, and local governments had access to state resources for their projects.

• The City of Amsterdam DRI Local Planning Committee has hosted more than 15 workshops, events, and public outreach events since last December – with meetings and materials delivered in multiple languages. The result: a community-informed, inclusive DRI Strategic Investment Plan with 20 new projects proposed to transform downtown Amsterdam on both banks of the Mohawk River.

 Schoharie County partnered with the SUNY Cobleskill, MVREDC, business leaders, and community stakeholders to compose a strategic plan that resulted in the formation of the Schoharie Economic Enterprise Corporation.

• REDC member and Montgomery County Executive Matt Ossenfort led an extensive public outreach effort with the citizens of Canajoharie and Montgomery county to formulate a Community Redevelopment Vision - with the primary goals of maximizing redevelopment while keeping connections to the village and the surrounding community, attracting new businesses and residents, and celebrating the area's history, its past industries, and the Erie Canal. The \$6 million RESTORE Project is nearing completion, and the MVREDC is prioritizing its first ESD application for private redevelopment of the site.

• This summer, the Village of Ilion, the Herkimer IDA and community partners launched a pop-up survey from a food truck. As a result, Herkimer partnered with Oneida county to apply for a coalition-based Strategic Planning and Feasibility Study application focused on smart growth in rural villages with municipal power.

 Otsego Now spent 2019 hosting town hall forums across Otsego County in order to cast a broader net for community input. With the conversations ranging from housing to industrial site development and environ-

mental justice concerns, the forums were also a great avenue to update residents and public officials on planned, underway, and completed projects.

• At this year's Center for Creative Land Recycling's Brownfield Redevelopment Summit in Albany, representatives from the Herkimer County IDA, City of Utica dominated the Redevelopment Pitch Competition; while Mohawk Valley EDGE representatives participated on two expert panels. Energized by the statewide exposure and feedback, the MVREDC Environmental Justice workgroup hosted an Inter-agency Brownfields Work Group for Ilion, Utica, and Rome at the Community Foundation of Herkimer & Oneida Counties in September.

• The MVREDC recently partnered with the Mohawk Valley Association of Realtors to win a grant from the National Association of Realtors to host an Opportunity Zone workshop in September; where the MVREDC will bring in experts from Buffalo, St. Paul, New Jersey, and Cincinnati to educate the public and work with potential investors to stimulate investment in low-income neighborhoods and designated zones in Rome, Utica, Little Falls, Herkimer, Amsterdam, Oneonta, Canajoharie, and Gloversville. The workshop is scheduled to take place this November.


#### **PROPOSED DRI AREA BOUNDARIES**

Utica's DRI strategy is informed and supported by multiple planning efforts, especially a recently completed, long-term Downtown Vision Plan prepared by global architecture firm NBBJ in collaboration with multiple community stakeholders. This visioning project was prompted by planning for Mohawk Valley Health System's (MVHS) \$480M Downtown healthcare campus, the largest-ever public-private project in the Mohawk Valley. The potential for the Downtown hospital project, among other New York State (NYS) and privately funded initiatives, to reshape Downtown prompted the City and its partners to embark on a process that resulted in a 10- to 20-year vision of Utica's urban core, taking into account recent, current, and aspirational development.

Working with community stakeholders, the consultant developed a dynamic and transformational vision for Downtown Utica; this vision's supporting constituent engagement resulted in the City's selection of the Genesee Street and Broad Street corridors as the DRI target area.

The target area provides realistic opportunities to realize the plan's goals for the long-term:

- Building pride in community and region
- Supporting economic revitalization



- Building on existing assets
- Celebrating history and heritage
- Enhancing connectivity
- Incorporating smaller plans and planning initiatives
- Building on the momentum of current projects

The target area was also selected based on its defining characteristics.

A street of Genesee's historical authenticity embodies Utica's distinctive character and identity, providing a central conduit and connection to diverse neighborhoods—each of which adds unique features to an increasingly vibrant urban core. Each district's identity is visible in the design of its public spaces, parks, streetscapes, and gathering places.

Each of Downtown Genesee Street's component areas enjoys a distinct look and feel characteristic of the uses and activities found there. Downtown Genesee Street is anchored on the north by the Broad Street-Oriskany Street/Route 5S gateway that leads into Franklin Square and on the south by Oneida Square. The lower end of Genesee Street serves as Downtown's Commercial District, with its Arts & Culture District further up the street.
