# **SOUTHERN TIER**

#### **REGIONAL VISION**

The focus of the 2022 Strategic Plan of the Southern Tier Regional Economic Development Council (ST REDC) is the development and implementation of a comprehensive business development and expansion plan anchored by a targeted workforce recruitment and retention strategy. This is in keeping with the New York State's (NYS) new workforce development initiative which has allocated substantial resources to develop and enhance a diverse and efficient workforce to satisfy the needs of NYS's various business sectors. For the Southern Tier (ST) this means meeting the present and future needs of the region's key industries and sectors: healthcare, advanced manufacturing, logistics, homeland & cyber security, and agribusiness.

Components of the plan focus on developing a targeted strategy that informs how the region can remain as a destination of innovation. This includes the refinement of resources and implementation strategies that ensure that ST continues to advance in a way that reinforces outcomes that cater to the size, quality, and prosperity of these key industries and sectors and their workforce needs. In developing a sustainable workforce strategy, we will build on past success, achieve new success, and in doing so ensure continued momentum. This will result in a sustainable approach to expanding and diversifying the ST regional economy while maintaining the uniqueness of the region's resources and history.


This report contains an overview of the state of the region, key regional priorities, a representative sample of awarded projects that align with the ST REDC's strategic goals, and a Workforce Development Inventory (WDI) intended to lay the groundwork to address the regions post-pandemic workforce needs.

The WDI is the initial phase of a two-phase approach to develop workforce development strategy for the ST, with the goal of positioning the region as a destination for business growth, research transfers from Cornell and Binghamton University, and increased entrepreneurial activity. However, for any of these to succeed, the ST must have a trained, diverse, and adaptable workforce for the short, intermediate, and long term. What follows is a brief description of the regions salient spatial, demographic, and employment characteristics.

#### OVERVIEW OF THE STATE OF THE REGION

The ST is comprised of eight contiguous counties (Broome, Chemung, Chenango, Delaware, Schuyler, Steuben, Tioga, and Tompkins) with a total area of 6,260 square miles. Five of the eight counties border Pennsylvania's Northern Tier. Per the 2020 census the ST has a population of 640,036. Although a substantial number of persons reside in rural areas and small towns, the region exhibits balance among its three largest metropolitan areas (Greater Binghamton, Elmira-Corning, and Ithaca) as measured by population and economic output.

The region has a several national and multi-national firms, two major universities, good vehicular accessibility, and a





Based on data collected between 2016-2021 in the key sectors of healthcare, advanced manufacturing, homeland and cybersecurity, agribusiness, and logistics, the ST lost 17,351 jobs (-8.3% decrease) with average private sector annual wages of \$57,359 (see table 3 below).


number of natural amenities. The region's top employers include United Health Services Hospitals, Ogden Arnot Medical Center, Cornell University, Lockheed Martin Corporation, Corning, Inc., and BAE.

The COVID-19 pandemic dramatically changed the ST's economic and workforce landscape creating unprecedented instability in the labor market across the region's key sectors. Between March 2020 and May 2020 unemployment in the ST rose to 16% (12% increase from December 2019), with significant job loss in key regional sectors such as leisure and hospitality, advance manufacturing, construction, transportation, and educational and health services (see tables 1 and 2 below).

Despite these challenges, economic indicators point to a recovery over the past twelve months. Recent data shows that private sector employment increased by 1.6% in May 2022. The increase in employment resulted in 3,400 private sector jobs. Among the more recent jobs gained, roughly 65% or 2,200 occurred in leisure and hospitality and professional and business services. In fact, the ST region's unemployment rate beginning in 2019 is below the state and national unemployment rates and has remained steady as of May 2022 (see chart below).



As we examine the current context for indications about future opportunities, targeted job training and education will be critical in addressing the ST's post pandemic need for quality labor. The ST REDC will support workforce development and training programs that connect worker skills with industry needs and align with strategic priorities for the region.

#### **CONTINUING REGIONAL PRIORITIES**

The ST REDC develops, promotes, and supports economic development initiatives aimed at creating a dynamic and versatile business friendly environment that is competitive in today's global economy. Since its inception in 2011, ST REDC has supported more than 850 projects with \$402,269,585 in public support through the Consolidated Funding Application (CFA) process. This has leveraged more than \$2,171,773,019 in private funds for projects throughout the ST for a total regional investment of more than \$2,574,042,604, and the creation and retention of more than 34,846 jobs. Our plan to build the ST's advanced economy and expand our workforce remains simple, but focused; these are:

#### Invest in the Advanced Manufacturing Sector

A focus on advanced manufacturing and the transportation sector is a key component in the continued growth of the regional economy while fostering the perception that the ST as a premier destination for manufacturing business development. Despite continuing supply chains challenges, strategic collaboration and investments will be pivotal in maintaining the region's competitiveness, spurring business growth in the ST's existing national and multi-national firms, while concomitantly engaging in attracting complementary new enterprises. The ST's factor endowments of a robust transportation infrastructure, a cluster of technologically and innovated businesses, a skilled workforce, and world class universities focused on applied research, puts the region in a position to continue to expand and enhance the ST's advanced manufacturing sector.

#### **Transform the Food and Agriculture Industry**

Improving the resiliency and self-reliance of the ST agriculture industry is critical in achieving the goal to transform the ST into a world-recognized leader in agriculture technology and serve as a key food supplier for the East Coast of the United States. Recent Investments in entrepreneurship in agriculture innovation and technology, culinary arts, and the dairy industry exemplify the transition and diversification of resources needed to transform and increase agriculture and food production, processing, and distribution across the region, while also strengthening links to growing tourism and manufacturing industries.

#### **Build the Greater Binghamton Innovation Ecosystem**

The Greater Binghamton Fund program is a revitalization initiative launched in 2018 with the goal of reinvigorating the interconnected urban core of the City of Binghamton, the Villages of Johnson City, and Endicott through investments in advanced manufacturing, healthcare, culture, and high-technology development in designated areas. The respective Innovation Districts ("iDistricts") in each municipality also pursue efforts that support small business development and capitalize on public-private collaborations through the growing presence of Binghamton University (BU) in Johnson City, the Koffman Incubator in Binghamton, and the Huron Campus in Endicott.

#### **Develop Tourism Business in the Southern Tier**

In addition to being a desirable place to live and work, the ST has many natural and cultural amenities to attract visitors. To maximize their attractiveness, the amenities need to be enhanced by a more robust regional promotional campaign, better wayfinding signage, and a well-trained tourism and hospitality workforce that delivers an unforgettable travel experience.

#### Promote the Southern Tier's Innovative Culture

Promoting the ST as a desirable place to visit, live, and start a business. We will continue to promote the region's quality of life and capacity for innovation. This, coupled with community pride, allows residents to be regional ambassadors to attract talent and inspire entrepreneurs.

What follows is a reiteration of the long-standing efforts of the ST REDC to shape the region's economic landscape, and its goal of building a more robust regional economy that will improve the everyday lives of ST residents.

# Regional Workforce Inventory

#### PRIORITY REGIONAL TRADABLE SECTORS



To better understand workforce needs beyond just skills training, and to contribute to a New York State (NYS) workforce development strategy that is industrydriven and enables workers to obtain quality jobs in the Southern Tier's (ST) high-growth industries, a ST REDC Task Force was created. The charge of the Task Force is to review the region's workforce development needs and identify gaps that need to be addressed by existing programs, and the formulation of new programs based on input from employers, training providers, and workers.

The Task Force is comprised of top workforce experts in the private and public sectors. Based on an analysis of data from the New York State Department of Labor (NYSDOL), complimentary information, and the Task Force's familiarity with the region, the Task Force formulated a "Regional Workforce Inventory" (RWI) that identified the region's post-pandemic workforce needs which include the following:

- Priority regional tradable sectors and/or state wide target industries for focusing workforce development efforts in the region.
- The most in-demand skill sets needed by employers in the region within these sectors/industries.
- 3. Populations for whom workforce training is most needed and justified.
- Wraparound services most needed to reach the target populations and eliminate traditional barriers to successfully build a sustainable workforce.

The goal of the ST REDC in formulating the RWI is to identify where regional workforce efforts need to focus on and select industries for which it wants to concentrate on the development of a workforce development strategy.

Among the region's tradable sectors, Advance Manufacturing, Healthcare, and Agri-business are highlighted in this RWI. These high-growth sectors have a profound impact on the ST regional economy and have the greatest potential for advancements in workforce development.

### **KEY SECTOR #1: ADVANCED MANUFACTURING** (AM)

Manufacturing continues to be an important tradable sector in the ST because of its legacy, institutional capacity, and high employment numbers. It also offers some of the greatest potential for growth in terms of supply-chain, commercialization of technology for business expansion, employee recruitment, foreign investment, and exports. Despite a large number job vacancies created by the pandemic, manufacturing continues to make significant contributions in exports, productivity, R&D, and wages.

The ST has one of the highest concentration of advanced manufacturing and transportation equipment manufacturing companies in NYS. According to NYSDOL, over the next five years AM is projected to see significant job growth. The ST excels in the design, manufacturing, and assembly of products for industries ranging from auto-making to high-speed rail, to aerospace. Focusing on the advanced transportation equipment manufacturing cluster provides a unique specialization in an increasingly global market, and an opportunity to increase jobs, private-sector investment, foreign investment, and global exports.

Despite these factor endowments, and projected job growth, the ST's manufacturing hubs, Greater Binghamton, Elmira, Corning, Hornell, and Norwich, suffer from pockets of poverty, older housing stocks, run-down commercial districts, and outdated infrastructure. Furthermore, the region's manufacturing sector is experiencing a rapidly aging workforce. In response, the region has several effective training institutions that can educate a new generation of workers as well as up-skill the existing workforce to meet technological changes. The exodus of college graduates, seasoned professionals, and young professionals is among the region's most pressing economic problems. The ST is challenged by its inability to recruit and retain enough professionals particularly in STEM fields to satisfy the workforce needs of the manufacturing sector. Based on NYSDOL surveys and input from the Task Force please find below the top five AM positions in need of workers.



#### TOP 5 POSITIONS needed and required skill sets:



#### Position: Machinist Required Skills:

- Excellent coordination and mechanical skills
- Basic math skills
- Strong attention to detail, accuracy, and safety
- Solid written and verbal communication skills
- Proficient in math, basic computer skills,
- Ability to lift up to 50 pounds and perform repetitive tasks

#### Position: Industrial and Mechanical Engineers Required Skills:

- Problem solving
- Decision making
- Critical thinking
- Knowledge of mathematics
- Ability to assess performance

#### Position: Assemblers and Fabricators Required Skills:

- Follow technical instructions
- Interpret engineering blueprints and technical terms
- Discern quality of parts and materials, inventory parts and tools
- Follow procedures
- Test finished products
- Maintain the tools used to create products

### Position: Maintenance and Repair Workers, General Required Skills:

- In-depth knowledge of mechanical and electrical systems maintenance
- Knowledge of parametric and industrial control systems
- Familiarity with OSHA safety standards and regulations.
- Excellent troubleshooting skills
- May need some welding skills as well

#### Position: First-Line Supervisors Required Skills:

- Knowledge of production planning
- Understanding of company goals and values
- Good communication skills
- Confident decision making
- Ability to act quickly
- Effective planning
- Detail oriented
- Ability to take ownership

#### TARGETED POPULATIONS for the AM Workforce:

The Task Force identified the following target populations for recruitment to the AM workforce, they are:

- Incumbent workers, train them and promote them
- Recovery to work individuals
- Veterans. Working with fort drum on their exit program would be a good move; there are people exiting with similar skillsets
- Underemployed young adults
- Justice-involved
- High school students involved with BOCES/PTECH
  programs or robotics teams
- Undecided college students
- Underrepresented minorities
- Current assembly workers
- Disengaged individuals

Overall, the potential for growth is here. Investment that is designed to connect educational opportunities with these target populations will be essential in improving the condition of our workforce inventory. By aligning local education and training entities and resources to better match talent with career opportunities throughout the ST, the region will ensure economic stability, reach individuals who are only marginally part of the labor force, support targeted training in partnership with regional employers, attract and retain young professionals and be better prepared for succession planning as a consequence of an aging population.

#### **KEY SECTOR #2: HEALTHCARE**

A talented, qualified, engaged, and diverse workforce is at the heart of New York State's health care system. However, like many hospitals and healthcare systems across the State, the ST is faced with critical staffing shortages that are creating challenging work environments and presenting a serious threat to quality care in the communities they serve. The COVID pandemic resulted in many healthcare professionals unexpectedly leaving the sector, which exacerbated hospital job vacancies. Input form taskforce members revealed that many of today's staffing shortages are due to career fatigue, better compensation (signing bonuses), lack of flexible scheduling, and opportunities for career advancement.

According to NYSDOL, growth in almost all health care occupations is expected to be in demand over the next decade. In 2018, there were over 34,000 healthcare jobs in the ST, nearly 13% of all ST jobs. The occupations with the greatest number of openings (Certified Nurse Aide, Home Health Aide) are low paying. Consequently, these positions should be part of a career ladder to LPN and RN positions.

Healthcare needs adequate staffing to provide quality care. A healthy community translates into a healthy workforce. Good healthcare services play a key role in other industry sectors; enabling employers to retain workers and recruit individuals to relocate to the ST. The COVID-19 pandemic reinforced how important quality; accessible healthcare services is to the normative functioning of all sectors and maintaining productivity. Specifically, programs that target increasing RN slots need to address the shortage of master's or Doctoral prepared nurses. Creating a pipeline is one way to help retain incumbent workers and help them advance to higher wage and essential jobs.



Ultimately, Healthcare holds a significant place in the quality of human capital. The increased expenditure in healthcare increases the productivity and quality of life, thus making a positive contribution to the economic growth of our region now and in the future.

The Healthcare industry infrastructure in the ST is well developed. The continued investment in the educational and creative recruitment tools for this targeted population will be the key in filling the need of healthcare workforce.

#### **KEY SECTOR #3: AGRIBUSINESS**

Despite the resiliency this sector has demonstrated in providing food and other necessities over the last two years, the COVID-19 pandemic revealed deficiencies in the agribusiness sector. There is an even greater urgency to understand the limits to the region's agriculture, processing, and distribution sectors.



Workforce is a major concern in the agribusiness sector for two reasons. First, as farm owners age, many don't have family members interested in taking over the family farm. Second, the situation is exacerbated by decrease in migrant labor in upstate New York. Although consumer demand for local and sustainable food has never been higher, ST growers, makers, distributors, and food retailers are finding it challenging managing a transparent supply chain. End-to-end logistics for small to midsize farms, transportation, cold-chain technology, and traceability tools are all desired, as are increased access to food processing facilities, including slaughterhouses, meatpacking and poultry processing facilities, dairy processing facilities and aseptic packaging facilities for vegetables.

Increasing the regional Agribusiness supply chain responsiveness and resilience could catapult the ST region from being a highly seasonal, occasional provider of food products to being a reliable and heavily utilized source of supply for the East Coast. This would contribute greatly to the economic growth of the region.

By incentivizing new Agribusiness venture creation in the region, this will spur innovative technology solutions to common grower and producer constraints, delivering higher yields and drawing participation from diverse populations. Identifying and shoring up pipelines to educational and practical experiences will address the narrow participant demographics of the current Agribusiness system by nurturing agricultural professionals from these diverse backgrounds.

A consequence of the pandemic was a reordering of the supply chain. The disruption of the pre-pandemic producer-supplier-consumer relationship saw the emergence of an opportunity for farmers to sell directly to the consumers, Although, this resulted in better profit margins for the producers, it also brought new challenges, such as managing customer relationships, keeping track of inventory, reaching customers, and filling orders. E-commerce platforms that help farmers sell more easily to customers online, streamline their marketing operations, and help connect farmers and buyers in their region would help address these challenges.

Efficient controlled environment agriculture (CEA) offers a longer growing season, increased crop diversity, decreased use of pesticides, and increased access to local foods throughout the year. By implementing best practices in green energy solutions for heating and lighting, it can be efficiently and quickly integrated into the ST's Agribusiness economy.

Providing additional technical assistance such as business plan development and better access to capital to producers who seek to innovate and enhance resiliency will put the ST at the vanguard of key areas of emerging Agribusiness growth and investment such as CEA, robotics and automation, novel crop protection, and supply chain technology. All these initiatives require increased broadband and cellular connectivity and digital skills development to assist local farms, farm businesses, food processors, distributors, and retail locations to achieve greater access to online sales, connection, and marketing.

By focusing development in emerging technology sectors such as CEA, robotics and automation, novel crop protection, and supply chain technology, and by supporting with infrastructure such as expanded broadband and cellular coverage, the ST can provide workforce opportunity to people from urban and suburban backgrounds without experience in traditional land-based agricultural sciences.

With more than \$5 billion in output, the ST's Agribusiness sector represents a significant part of its economy with vast potential to expand production built on the region's expertise in food production. With its large acres of farmland, its abundant fresh water, its proximity to key East Coast markets, and the global reach and strengths of Cornell University's College of Agriculture and Life Sciences, the ST is well-positioned to continue supporting a strong Agribusiness sector.

As traditional centers of agriculture production outside of the Northeast face production challenges due to draught, natural resource scarcity, and the visibility of supply chain vulnerability exposed during the COVID-19 pandemic, the ST has an opportunity to scale up production to meet demand for food products within NYS and throughout the Northeast through developments in plant science technology, controlled environment agriculture, robotics and automation, distribution and storage technology, and renewable energy.

Workforce development and training are essential in capitalizing on the ST's unique opportunities to increase food production, processing, and distribution. Workforce development is important as farm operators get older. In addition to supporting farmer education and training programs, the ST has acknowledged the importance of increased workforce training in critical support areas of production, including veterinary programs, animal care programs, controlled environment agriculture technicians and processing technicians. There is an opportunity for the region to take advantage of existing training capacity and expertise at Cornell, Corning Community College, SUNY Broome, SUNY Delhi, and the burgeoning Groundswell Farmer Incubator program targeting BIPOC farmers, immigrants, veterans, and vulnerable workers.

The WDI Task Force outlined multiple target populations to grow and improve the Agribusiness workforce:

- Incumbent workers, train them and promote them
- · Recovery to work individuals
- Underemployed young adults
- High school students involved with BOCES
- Underrepresented minorities
- Individuals with no former training or education

In terms of geography, the WDI Task Force identified that this targeted workforce population currently lives throughout the Southern Tier Region in both rural and urban settings.

Agribusiness is a strong industry sector in the Southern Tier region and by investing in building this workforce, it will continually impact the region with more economic growth.

#### WRAPAROUND SERVICES

#### EDUCATION AS THE KEY WRAPAROUND SERVICE

The Task Force outlined education a reoccurring theme for it touched every key sector that supports the ST regional economy. From K-12 to college, the skillsets required involve training, specific knowledge, some require certification, and all involve problem solving and critical thinking. This led to the conclusion that education is a necessary service if we are to develop the required workforce for the ST.

### Recommendations of Education Investment included the following:

- Better job preparation with open communication about what is involved, create the opportunities to experience the physical environment of the position (virtually or in-person), job shadowing
- Review state regulations for various certifications to improve access
- Create incentives to motivate the labor force orientations, onboarding, on-the-job training
- Development of long-term financial assistance to promote family members to stay in key industries and pursue further education and/or certification
- Develop clear pipeline programs targeting youth in K-12 to introduce them to opportunities in key industries
- Highlight the accessibility of certification programs that lead to industry positions in need
- Access to ongoing training and coaching for potential promotion and internal growth

#### Childcare

Developing childcare services that can adapt to various schedules, would help workers in all key industries. Many positions require availability at different times. This would be a major benefit to support those workers and encourage long-term employment and skill development.

#### **Transportation**

Transportation investment would ensure availability of the workforce. Transportation is a necessity when considering the expanse geography and physical distance that exists within the ST. It is a needed service for both workforce populations: rural and urban.

#### Additional Wraparound Services

- Payment during any training
- Creative scheduling
- Housing support
- Access to mental health/drug abuse counseling

#### **REGIONAL GOALS:**

- Create a supportive ecosystem, ranging from basic infrastructure to state-of-the-art equipment, to the community support systems essential to attracting and retaining young talent that will stimulate private investment.
- Commit to sustaining the ST's competitive edge by fostering relationships with internal corporate and research universities to commercialize new innovations.
- Create a skilled workforce by anticipating and meeting future workforce needs.
- Increase engagement between students and industries that inspires and prepares the next generation for careers in advanced manufacturing, healthcare, and agribusiness; transform the role of the schools in high-poverty areas to contribute to a culture shift in perceptions about these key industries; and train adult incumbent and unemployed workers in workforce readiness.

Our ability to keep these key industries in this region is critical. Without an adequate workforce, manufacturers, healthcare employers, and agribusiness may be forced to move to other states. In particular, those states with lower costs of doing business and more robust incentive programs. This also affects worker's decisions, especially those motivated by a better climate and a lower cost of living.

The ST recognizes that a strong workforce is one of the key components of sustainability and growth in these sectors. The ST will focus on attracting more qualified workers with different and more technical skill sets to ensure the future competitiveness of the sector. Steps will need to be taken to expose young people to career opportunities, engage the existing workforce in training, and aggressively recruit new talent at all levels. PART THREE

## Public Outreach and Engagement



The ST's 2022 regional plan for economic development is a result of a collaborative effort that includes a reevaluation of investment strategies, local policies, objectives, and goals that have informed decisions on project development and the allocation of resources at the local, state, and federal levels.

The ST REDC workgroups are a critical driver of our regional strategy– they identify, develop, and implement regionally significant projects through a project pipeline in support of key state and regional priorities. Over the last year, the ST REDC Co-Chairs, workgroup members, and key stakeholders have participated in surveys and routinely corresponded and engaged via virtual and in-person meetings to discuss important issues and review proposals relevant to the recovery and success of the regional economy. This effort also included ST ESD staff which provided shared updates on existing ESD programs, and information about new ESD programs, as well as relevant programs from state agencies such as DOS, HCR, and others.

With NYS enhanced focus on workforce development the 2022 regional plan is driven by research and input from members of workgroups that consist of industry and academic leaders, members of local institutions, economic development professionals, and public engagement with consideration of demographics and economics of the ST

# **Previously Funded CFA Projects**

PART FOUR

Beginning in May of 2021 the ST REDC implemented strategies to support key sectors that were significantly impacted by the pandemic. These sectors include agribusiness, advanced manufacturing, healthcare, and tourism. The following projects are a representative sample of projects recommended by the ST REDC and align with the ST REDC regional priorities and effectively respond to the needs of companies and the communities that support them.

## 2021 Regional Highlights

#### Amphenol Aerospace | Village of Sidney, Delaware County

Amphenol Aerospace in the Village of Sidney, Delaware County, is a division of Amphenol Corporation, will invest over \$18 million in a facility expansion and new, advanced technology equipment at their plating facility. The investment will support a 30% increase in plating capacity, improve product quality metrics by 55% to meet the rapidly evolving technology standards in advanced manufacturing, and provide for efficiency and safety upgrades benefitting employees and the environment. The project entails a two to three-year program of investment to construct a 40,000 sq.ft. expansion to their existing plating facility and install automated plating processing equipment. This project will save up to 30 at-risk jobs that would be lost without the investment at this facility and is critical for their long-term ability to maintain 950 jobs in the region.

#### Odyssey Semiconductor Technologies Inc. | Town of Ithaca, Tompkins County

Odyssey Semiconductor Technologies Inc, Town of Ithaca, Tompkins County fabricates gallium nitride power semiconductor devices. In response to the ongoing global semiconductor chip shortage and more local efforts to expand green technologies, the company anticipates meeting this increasing demand by expanding their manufacturing capabilities. This expansion effort will include construction of a 3000 sq ft facility and the purchase of machinery and equipment to scale up their semiconductor manufacturing. These new and upgraded semiconductor processing equipment will enhance the existing manufacturing capability from the current estimated ability to produce 50 wafers per month to an estimated 500 wafers per month. Upon completion the company will retain 11 job and create 21 new full-time jobs in the region.



SUNY Broome Culinary School

#### SUNY Broome Culinary School | City of Binghamton, Broome County

In 2021, SUNY Broome completed its renovation of a 25,000-square-foot vacant, historic building in downtown Binghamton, Broome County. The former public library now provides an advanced learning environment for the college's Culinary Arts Program, and its Hospitality and Events Management Programs. Besides repurposing the property, the proximity of the school to downtown restaurants enables synergies between the program's students and local dining establishments.



#### **Cornell University Grow-NY Program**

Beginning in the Fall of 2022, the Cornell University Grow-NY program will continue for another three consecutive years (2022-2024). The competitionbased program attracts innovative, high-growth food and agriculture startups from across the globe and introduces them to upstate New York's rapidly growing agribusiness sector. This includes food and agriculture companies at every point in the agri-food value chain that are working to serve a growing population, while striving to employ sustainable, environmentally conscious, and/or healthy methods.

The program area encompasses three contiguous ESD regions, the Southern Tier, Central NY, and the Finger Lakes, totaling twenty-two counties. Applicants to the program compete for \$3 million in annual awards. Winning applicants are required to execute plans that advance innovative products and services, create jobs, and complement local agribusiness partners. Upstate benefits by the resulting agricultural innovation that enhances and expands this key upstate sector.



2021 Grow NY Winner - Trish Thomas CO-Founder/CEO of Every Body Eat

#### Ubiquity Solar Inc. | Broome County

The Canadian firm Ubiquity Solar Inc. will establish a solar photovoltaic manufacturing operations at the Huron Campus in the village of Endicott in Broome County. Through a \$61 million investment, the company will repurpose 800,000 square-feet of space. Besides leasehold improvements, the project entails the purchase and installation of production equipment.

Once operational, the company expects to produce 1.5 MWp of advanced space grade PV cells for aerospace customers and 350 MWp of utility grade PV cells for the power generation market in 2022. In the US, the average size of a new PV system on a single-family residence is 7kWp, meaning the initial production line of 350MWp could power 50,000 average sized homes. Ubiquity Solar anticipates to create up to 150 highly skilled jobs in the region.



The project is underway, and the company expects to be fully operational by the end of 2022. ESD is participating in the project with up to \$3 million through the Excelsior Jobs Tax Credit Program. This investment will contribute to the ongoing revitalization at the campus, which currently houses complementary advanced manufacturing tenants.

In the 2021 DRI Round 5, each of ESD's ten regions were awarded \$20 million in DRI funds, to assist communities in attracting private and public sector investments to their downtowns to advance their housing, community development, and economic development goals. The ST REDC conducted a thorough and competitive review process of proposals submitted from the region and recommended the Village of Endicott, Broome County, and the City of Norwich, Chenango County as its 2021 DRI nominees.

#### Village of Endicott | Broome County

In response to the growth of their Advanced Manufacturing I-District, Endicott aims to create a synergistic and complementary relationship between the downtown area and the companies in the district by creating a downtown suited for 21st century jobs. Endicott is already well-underway with this plan as they have seen over \$600 million invested in the village in the past 10 years and have public and private projects ongoing or expected within the next 3 years that total \$300 million in investment. Building on this momentum, Endicott wants to create new food and entertainment opportunities, improve connectivity, and increase mixed-use space.

#### City of Norwich | Chenango County

With a location that is within a 50-mile radius of major Upstate cities, including Binghamton, Syracuse and Utica, Norwich is positioned to build on their history of innovation and creativity to become an "authentic urban substitute" in response to a changing American economy. Norwich has focused its efforts on their downtown area, including the mixed-use redevelopment of a former manufacturing facility, improving connectivity between the local museums, and focusing on clean energy development, which has brought 3 solar farms within 5 miles of the city since 2019. Building on these efforts, the city aims to support new businesses, expand entertainment options, improve bike/pedestrian safety and accessibility, and increase mixed-use space.

While most of the economic and community development goals of the 2022 plan remain unchanged from prior years strategic plans, this year's focus will be on workforce development in response to the establishment of Empire State Development (ESD) new Office Workforce Development (OWD). For the ST to avail itself of funding coming most effectively from the OWD in the formulation of this year's plan, we have engaged the assistance of ST REDC and non REDC members who are engaged daily in workforce development and related issues such as childcare and transportation.
