Lieutenant Governor Antonio Delgado: welcomed and thanked the LIREDC. He stressed the importance of "good jobs" for a community to thrive. Shift of focus from top-down approach to bottom up—listening and engaging with community is how to move forward.

3:00pm Regional Council Update and Request for Applications

Cara Longworth, Executive Director LIREDC

Cara gave an overview of Round 12 REDC grants: 14 projects awarded so far, ~\$10m awarded with ~\$45M leveraged and 723 jobs created/retained. The next batch closes April 14th and the new round after that is expected to open on May 1. All other eight agencies have announced their awards from round 12. The DRI projects for Amityville and Riverhead have been announced and are moving forward.

The new DRI (the Town of Huntington for Huntington Station) was recently announced. As well as the NY Forward awardees: Long Beach and Lindenhurst. Council members have been assigned to the locations for the Local Planning Committee meetings (Dave Kappel- Huntington, Resi Cooper- Long Beach, and Jim Morgo- Lindenhurst). If there are other Council members who would like to join the LPC meetings, please reach out to Cara.

Jim Morgo commented that both Linda and John did a great job at the DRI Round 5 project announcements event.

Cara gave an overview of the Long Island Investment Fund—what has been awarded thus far; four awards have been announced totaling \$56M: Farmingdale State College, Long Island University, Feinstein Research Institute, and Brookhaven National Lab/Stony Brook University.

Cara reminded all that the recent Request for Applications for Life Sciences and Workforce Development Training Center has been made public, both can be found on the ESD website, (https://esd.ny.gov/doing-business-ny/requests-proposals) and both are due by March 31st.

Cara explained the workforce development critical initiative through the two-phase process. Phase one was an inventory done in part with a survey from DOL/ESD. Ernst and Young was hired for Phase 2 for solution driven strategic plan. An advisory committee was formed that met three times throughout the summer and fall as well as numerous focus groups and interviews.
